

In The Matter of:

Mariola Abilheira (#0227490), Licensed Real Estate Salesperson/Respondent

WHEREAS Respondent Mariola Abilheira, a licensed real estate salesperson licensed by the State of New Jersey, is subject to the provisions of the Real Estate Brokers and Salesperson's Act, N.J.S.A. 45:15-1 et seq.; and

WHEREAS at all times relevant hereto, Respondent Mariola Abilheira was and continues to be licensed as a salesperson with Hassle Free Realty, LLC d/b/a Re/Max Re/Max Homeland Realtors whose office is located at 42 East Main Street, Freehold, NJ 07728; and

WHEREAS the Real Estate Commission has secured evidence which indicates that Respondent Abilheira has violated certain provisions of the laws and regulations governing the conduct of New Jersey real estate brokers and salespersons as referenced above; and

WHEREAS the Commission and Respondent Abilheira have agreed to settle this matter in lieu of any further administrative action; and

WHEREAS Abilheira acted as the listing agent for the property located at 453 Route 33, Millstone, NJ; and

WHEREAS on August 2, 2011 an offer to purchase was presented by Vikram Konda, along with a check in the amount of \$1,000 payable to "Re/Max Homeland Realtors" to Abilheira; and

WHEREAS the check was not deposited by Re/MAX Homeland Realtors until October 21, 2011; and

WHEREAS, Respondent Abilheira admits that she acted in violation of N.J.S.A. 45:15-17(d) by failing to account for or to pay over moneys belonging to others coming into her possession; and

WHEREAS Respondent Abilheira acknowledges that she has been made aware of her right to a full and formal hearing on any violations which the Commission may allege she has committed and her right to have the advice of counsel on the matters to which this Consent Order pertains, she is knowingly and voluntarily waiving the right to a hearing and counsel; and

IT IS THEREFORE AGREED TO BY THE PARTIES AND SO ORDERED that

Respondent Abilheira agrees to pay a fine in the amount of \$1500.00; and it is further ordered and agreed that

Respondent Abilheira shall pay the fine within 30 days of the date of acceptance of this Consent Order. The fine shall be payable by certified check, cashier's check or money order payable to the "State of New Jersey" and sent to:

And it appearing that this matter can be resolved upon the consent of the parties, without resort to any other further administrative proceeding;

ORDERED and AGREED that the terms of this Consent Order are approved by the Commission at a regular meeting on May 4, 2016; and

It is further ORDERED AND AGREED that the Commission reserves the right to take further administrative action if the terms of this Consent Order are not fully complied with or if it obtains any other information that the respondent may have violated the Real Estate Brokers and Salesperson's Act, N.J.S.A. 45:15-1 et seq. or corresponding regulations, N.J.A.C.11:5-1.1 et seq.;
