- Each submitted application must contain an Application Fee. After application approval, the applicant will be issued an official							
Certificate of Examination Eligibility All applicants must first pass the formal NJ real estate Pre-License Instructor examination and then be fingerprinted.							
- Finally, successful new Instructors MUST physically attend at least one, of the two, mandatory Pre-Licensure Instructor's seminars held in
