

## Contact Information (Email, Address, Phone) NJREC or Public

The Real Estate Commission collects contact information for the purpose of communication between the REC Commission and the licensee. For individuals actively licensed with a Real Estate company, the company's business address will be used as the primary address for the licensee. For those not licensed with a Real Estate company, communication will be sent to the email and/or address on file.

The Commission periodically receives requests for information on licensees in accord with the Open Public Records Act (OPRA). Any information identified as "NJREC only" will not be included in the response to these requests. Information identified as "Public" will be treated as shareable business information which may be included in the data provided in response to an OPRA request. An individual licensee may choose to identify an address, email, or phone number as "Public." Doing so would authorize the Commission to share that information with any member of the general public submitting an OPRA request. Please give careful consideration before identifying contact information as "Public."
