

**NJREC CONTINUING EDUCATION (CE) CREDIT HOURS REQUIRED TO CHANGE LICENSE TYPE FROM  
SLWRERC (SALEPERSON LICENSED WITH REAL ESTATE REFERRAL COMPANY) TO OTHER NJ LICENSE TYPES:  
BROKER (BR), BROKER-SALESPERSON (BR-SP), SALESPERSON (SP)**

formerly known as the Referral Agent (RA)**

**THE SLWRERC LICENSE TYPE  
BECAME EFFECTIVE AS OF "2018"**

***A SLWRERC who "was not previously licensed" as a Broker, Broker-Salesperson or Salesperson and who has been licensed as a SLWRERC.***

11:5-3:15(a)	<b>Less than 1 year</b>	Shall be eligible for licensure as a <b>SALESPERSON</b> without being required to complete any CE.
11:5-3.15(b)	<b>Between 1 year and 6 years</b>	A <b>SLWRERC</b> who <b>was not</b> previously licensed, shall in order to qualify for licensure as a <b>SALESPERSON</b> , <b>shall complete (24) hours of CE, all of which shall be in CORE and/or ETHICS topics only, within the 2 years immediately preceding application.</b>
11:5-3.15(c)	<b>More than 6 immediately preceding years</b>	A <b>SLWRERC</b> who <b>was not</b> previously licensed, shall in order to qualify for licensure as a <b>SALESPERSON, shall complete the pre-licensure education requirement applicable to NJ Salespersons AND pass the NJ State license examinations for salespersons. (NO CE REQUIRED)</b>

***A SLWRERC who "was previously licensed" as a Broker, Broker-Salesperson or Salesperson who has been licensed as a SLWRERC for the six (6) immediately preceding years or any lesser period shall, in order to qualify for reissuance of a Broker, Broker-Salesperson or Salesperson license, complete the hours of continuing education within the two (2) years immediately preceding application, as set forth in N.J.A.C. 11:5-12.4 below:***

11:5-3:15(d) 1.	<b>Less than 3 years</b>	A <b>SLWRERC</b> who was previously licensed as a <b>SALESPERSON</b> who has been licensed as a referral agent, in order to qualify for a re-licensure as a salesperson, <b>shall complete (12) hours of CE, all of which shall be in CORE and/or ETHICS topics only, within the 2 years immediately preceding application.</b>
11:5-3.15(d) 2.	<b>More than 3 years, but less than 6 years</b>	A <b>SLWRERC</b> who was previously licensed as a <b>SALESPERSON</b> who has been licensed as a referral agent, in order to qualify for a re-licensure as a salesperson, <b>shall complete (18) hours of CE, all of which shall be in CORE and/or ETHICS topics only, within the 2 years immediately preceding application.</b>
11:5-3.15(e)	<b>More than 6 immediately preceding years</b>	A <b>SLWRERC</b> who was previously licensed as a <b>SALESPERSON</b> who has been licensed as a referral agent, in order to qualify for a re-licensure as a salesperson, <b>shall complete (30) hours of CE, all of which shall be in CORE and/or ETHICS topics only, within the 2 years immediately preceding application.</b>
11:5-3.15(d) 3.	<b>Less than 3 years</b>	A <b>SLWRERC</b> who was previously licensed as a <b>BROKER or BROKER-SALESPERSON</b> who has been licensed as a referral agent, in order to qualify for a re-licensure as a Broker, or Broker-Salesperson, <b>complete (18) HOURS of CE all of which shall be in CORE and/or ETHICS topics only.</b>
11:5-3.15(d) 4.	<b>3 years or more, but less than 6 years</b>	A <b>SLWRERC</b> who was previously licensed as a <b>BROKER or BROKER-SALESPERSON</b> who has been licensed as a referral agent, in order to qualify for a re-licensure as a Broker, or Broker-Salesperson, <b>complete (24) HOURS of CE all of which shall be in CORE and/or ETHICS topics only.</b>
11:5-3.15(e)	<b>More than 6 immediately preceding years</b>	A <b>SLWRERC</b> who was previously licensed as a <b>BROKER or BROKER-SALESPERSON</b> who has been licensed as a referral agent, in order to qualify for a re-licensure as a Broker, or Broker-Salesperson, <b>complete (30) HOURS of CE all of which shall be in CORE and/or ETHICS topics only.</b>
