Water Management Advisory Committee MEETING HIGHLIGHTS

Thursday, June 21, 2018 10:00 a.m. – 12:00 p.m.

The DRBC Water Management Advisory Committee (WMAC) was called to order by Ms. Kathy Klein, Committee Vice Chair. Information pertaining to the WMAC, including member listing and past meeting materials, is available at <u>http://www.nj.gov/drbc/about/advisory/WMAC_index.html</u>

Administration

- The highlights of the October 24, 2017 meeting were approved and will be posted on the WMAC webpage.
- Membership: WMAC Member Vacancy for League of Women Voters or other Civic Organization is open until filled. We have received letters of interest from John Thaeder (Artesian) and Jim Merson (Merrill Creek) for reappointment to the WMAC as the Utility and Industry representatives, respectively, as their terms expire. DRBC staff will follow-up with both John and Jim. Please see the DRBC website (http://www.nj.gov/drbc/about/advisory/committee-openings.html) for more information.
- Election of Chair/Vice Chair: Kathy Klein (WRA) has been elected as the new chair of the WMAC. Her term as chair will start July 1, 2018 through June 30, 2020. John Thaeder (Artesian) has been elected as the new vice chair of the WMAC. His term will also be from July 1, 2018 through June 30, 2020. It is the intention of the WMAC that at the end the two-year term, the vice chair would be elected as chair for the next term.
- WMAC meeting scheduled for Thursday, October 25, 2018 was rescheduled for Thursday, October 18, 2018.

HYDROLOGIC CONDITIONS REPORT

Dr. Hernon Quinodoz, Sr. Water Resource Engineer for DRBC Water Resource Operations, provided a report on basin-wide hydrologic conditions. Year-to-date, the basin has experienced slightly higher amounts of precipitation compared to the same time of the year in 2014 and 2015. The combined New York City reservoir storage is 96% of usable capacity and near the long-term median for this time of year. Lower basin storage pools in Beltzville and Blue Marsh reservoirs are at or above 100% and Merrill Creek reservoir is at 96%. Streamflow at the USGS gages indicate flows are mostly normal or above normal, with a few locations below normal in the Upper Basin. Currently, the salt front is at River Mile (RM) 68 compared to a normal location at RM 69 for this time of year. As of June 20th, groundwater levels in the USGS monitoring wells indicate normal or above normal levels. The 3-month outlook from NOAA show that temperatures and precipitation have a slight chance of being higher than normal in the Delaware River Basin region.

DRBC UPDATES

Dr. Ken Najjar, DRBC Director of Water Resource Management, provided an update on DRBC activities, upcoming advisory committee meetings, Commission actions, and other items of interest, among them:

- At the May 16 public hearing, the Commissioners were presented with 28 Dockets, the FY 2019 Budget, and Consumptive Use Policy. Public testimony included comments on the Gad Eden Estates (NY) Docket.
- At the June 13th Business Meeting, the Commissioners approved 27 out of 28 Dockets (all but Gan Eden Estates) and Resolutions for the FY 2019 Budget, Consumptive Use Policy, and Professional Engineering Services for Technical Evaluations and Cost Estimations for Upgrades of Wastewater Treatment Plants Discharging to the Delaware River Estuary.
- The remaining 2018 schedule for public hearings/business meetings is: Aug 15/Sept 13, Nov 14/Dec 12.
- DRBC published draft HVHF rules on November 30, 2017 and the comment period ended March 30, 2018. DRBC received around 9,000 submissions through SmartComment and tens of 1,000s of petitions/signatures within those submissions on the draft HVHF rules. The comments are under review and DRBC will prepare a comment/response document (no schedule determined).
- Upcoming DRBC Advisory Committee meetings include: WQAC on July 18; TAC on July 26; and WMAC on Oct 18.
- Water audit trainings will be held in two basin states : August 8 by NJDEP at Rutgers New Brunswick; and a 3-part training series by DRBC/PADEP at Buck County Community College in Newtown on September 27, October 23, and November 28.
- Ken announced the retirements of: Jessica Sanchez, former WMAC liaison, on January 1, 2018; Tom Fikslin, Director of Science and Water Quality Management, and Clarke Rupert, Communications Manager, on April 1, 2018; and Carol Adamovic, Accounting Assistant, on May 1, 2018.
- Namsoo Suk has been promoted to Director of Science and Water Quality Management.
- DRBC has 3 new hires: Seung Ah Byun, Water Resource Engineer; Jake Bransky, Aquatic Biologist; and Stacey Mullholland, Public Affairs Specialist.

WATER AUDIT UPDATES

Dr. Ken Najjar discussed the status and trends of the water audit program, including trends in water use. The basin export trends have remained relatively flat while consumptive use trends for 3 major sectors (public water supply, industrial, and thermoelectric) have varied over time but have been generally flat since the 1980's. The purpose of DRBC's water audit program is to track how efficiently water is moved from its source to the customer (within a public water supply

system) and to ensure that systems quantify and are accountable for water losses. The water audit program also helps to raise awareness of best practices and trends in conservation. DRBC uses the IWA/AWWA Water Audit methodology, which provides a standardized approach to water audits and better indicators for overall better water loss management. Since the adoption of regulations in 2009 requiring the submission of water audits by public water systems, compliance has steady improved.

CONSUMPTIVE USE POLICY

Chad Pindar, DRBC Manager of Water Resource Planning, gave an overview of the recently adopted Power Consumptive Use Policy (Resolution No. 2018-5). Through resolution the new policy clarifies and restates the Commission's Policy for replacing of water consumptively used by electric generating or cogenerating facilities during Critical Hydrologic Conditions. The new policy resolves inconsistencies by:

- Formalizing a policy that has been in practice for decades.
- Defining "critical hydrological condition."
- Updating the "standard condition" in dockets over time.
- Updating the Merrill Creek Owners Group (MCOG) docket's operating plan.
- Providing clarification and guidance on: applicability; relative effect factor; replacement sources; exemptions; and notifications.
- Replacing Drought Management and Contingency Plan (DMCP) with Consumptive Use Replacement Plan (CURP) and establishing criteria for CURP.
