Members raised the following questions/ issues:

- Incorporating climate change, e.g., sea level rise, precipitation delivery changes, into
  planning programs as well as siting of infrastructure: PA, PWD, DE and DRBC indicated
  that they are actively pursuing the implications of climate change for water resource
  management.
- What has been the effect of the SE GWPA program on stream flow?
- Transparency and accessibility: agencies should make the data and analyses available.
- Is the 1:25 year metric adequate, i.e., is it protective of instream/ecological flows?
- The presentations highlight the difference and disparity among groundwater management programs; is there a different approach that could be used uniformly/consistently across the basin?

Since time was short, staff offered to prepare a brief survey questionnaire to capture ideas and issues from Committee members.
