

# SECTION VI

## USING THE DOEnet BUDGET SOFTWARE TO TRANSMIT SCHOOL-BASED BUDGETS

### A. General Overview of the School-Based Budget Completion Process

Beginning with the 1999-2000 budget year, certain districts were required to submit school-based budgets for their schools. A blended resource fund (fund 15), a subfund of the general fund, was created to allow budgeting of school-level appropriations and accounting for school-level expenditures. Revenues are recorded in fund 15 as operating transfers from the general fund (fund 11) and special revenue fund (fund 20).

School-based budgeting is maintained in the DOEnet budget software. Districts that were required to submit school-based budgets in previous years are required to continue to do so for 2012-13. As such, those districts must enter school-based budget information into the DOEnet budget software and complete the school-based budget screens of the DOEnet budget software.

Districts submitting school-based budgets as part of their district-wide budget submission must enter the School-Based Budget Menu from the main data entry screen of the DOEnet budget software. Districts will enter the school-based revenues, appropriations, and staffing information directly into the district-wide software. The DOEnet district-wide budget software will include edits for agreement between the amounts entered in the school-based budget screens and the amounts on general fund line 9466 and special revenue fund lines 9651 and 9731, as applicable. Audited expenditure data for fund 15 for 2010-11 will be preloaded from Audsum. The 2011-12 budget information will be preloaded into the 2011-12 column. These amounts must be updated to reflect the revised budget as of February 1, 2012.

Changes to the detailed revenues for 2012-13 include:

#### ECPA Prior Year Carryover

Revenue line 670 for ECPA Prior Year Carryover has been blocked for use in 2012-13. All ECPA carryover should have been utilized.

Under NCLB, districts are encouraged to blend eligible funds for eligible schoolwide programs in Fund 15. Schoolwide status is determined on a school by school basis based on poverty levels and having an approved schoolwide program plan. Simply being a school in a district that prepares school-based budgets does not make the school eligible to operate a schoolwide program. One of the requirements of implementing schoolwide programs is to integrate, whenever possible, all local, state and federal resources into one funding stream to upgrade the entire school. It is therefore important that districts are cognizant of the federal laws permitting blending of federal resources, particularly the

Included at that site is a July 2004 document titled "Notice Authorizing Schoolwide Programs to Consolidate Federal Education Funds."

The basics of a schoolwide program are summarized below. The above resources should be referenced for more detailed and specific information relating to operating a schoolwide program.

NCLB permits a local educational agency (LEA) to consolidate and blend funds "together with other federal, state and local funds, in order to upgrade the entire educational program of a school that serves an eligible school attendance area in which not less than 40 percent of the children are from low-income families, or not less than 40 percent of the children enrolled in the school are from such families" (NCLB §1114). The purpose is to increase the academic achievement for all students in the school by allowing schools to integrate their programs, strategies and resources.

A Title I targeted assistance program uses Title I, Part A funds only for the provision of supplementary educational services to eligible children who are failing, or at risk of failing, to meet state standards. In a Title I schoolwide program, a school is not required to provide supplementary services to identified children but instead can upgrade the entire educational program in the school.

In order to be eligible for a Title I schoolwide program, the school must be eligible for the Title I program; receive Title I, Part A funds; have at least 40 percent of the children enrolled in the school or residing in the school attendance area be from low-income families; comply with a year of planning; meet the nine essential program components; and, be approved to operate a schoolwide program. To promote effective, long-term planning, a school can maintain its schoolwide program eligibility even if it drops below the 40 percent poverty threshold. However, the school must still meet Title I eligibility and receive Title I funds.

Title I eligibility is a prerequisite of schoolwide program eligibility. Without an **approved** schoolwide program, a school is not permitted to blend federal funds with state and local funds. Schoolwide programs are to be approved by the department. These ineligible schools may only blend state and local funds.

*Only eligible Title I schools receiving Title I funds may operate schoolwide programs.*

Only schools with approved schoolwide status may combine federal funds in their school-based budgets.

Lines are included in the detailed appropriations section of the budget for the general fund (line 9466 –General Fund Contribution to School-Based Budget) and special revenue fund (lines 9651 –Other State Projects (Restricted) Contribution to School-Based Budget, and 9731- Other Federal Projects Contribution to School-Based Budget) contributions to blended resource school-based budgets for 2012-13.

The amounts reported in the district-wide budget for the contributions to the blended resource school-based budgets are a summary of the amounts reported as revenues from those sources in the school-based budgets. The school-based budgets must be entered and the revenue sources identified in order to determine the amounts to be reported in the district-wide budget. The general fund contribution amount is the sum of the local resources (taxes, surplus, miscellaneous revenues, tuition, etc.) and unrestricted state aids from the district’s general fund budget that is dedicated to supporting the blended resource school-based budgets. The restricted aid contributions are the allocations of those aids to the school-based budgets. The budget software will contain edit checks for agreement between the following lines of the district-wide detailed appropriations and the total of the amounts reported in the school-based blended resource fund revenues for 2012-13 and 2011-12, respectively:

The advertised per pupil cost calculations of districts completing school-based budgets include disclosure of the per pupil amount of certain restricted state and federal entitlements in the blended resource budgets that are contained in those calculations.

**B. Budgeting for 2012-13 Education Jobs Fund**

Education Jobs Fund appropriations may not be blended in school-based budgets, and therefore should not be recorded in fund 15. The Education Jobs Fund appropriations are to be recorded in fund 18 and rolled into fund 11 appropriations in the budget software. See the general guidance to all districts included in Section I of these guidelines.

**C. Budgeting and Accounting for Approved Preschool Program and Appropriations**

The preschool funding and program requirements were amended under SFRA. The general guidance to all districts is included in Section II of these guidelines.

**D. Budgeting the Estimated TPAF, FICA and Medicare Reimbursements Associated with the Salaries Allocated to Federal Programs in a School-Based Budget**

N.J.S.A. 18A:66-90 requires each public employer (district) to reimburse the State for the amount of TPAF, FICA and Medicare paid by the State on behalf of the district for contractual teacher salaries charged to federally funded programs. For 2012-13, districts must calculate and budget the amount due to the state for contractual teacher salaries charged to federally funded programs. Prior to the implementation of blended resource school-based budgets, this reimbursement was calculated on Title I and other federal program teachers and included on the benefits line of the applicable grant application.

The implementation of school-based budgets, and the blending of federal, state and local funds in the school-based budget recorded in fund 15, necessitates a calculation of the salary amounts paid in fund 15, which are attributable to federal sources. Once this calculation is performed, the budgeted TPAF, FICA and Medicare reimbursements can be determined and included in the related grant application.

The instructions below detail how to calculate an estimate of the reimbursement due to the State for the TPAF, FICA and Medicare associated with the federal portion of salaries blended in a school-based budget. This calculation should be performed for each school with a blended resource school-based budget with schoolwide program status. The reimbursement calculated below should be included on the benefits line (200-200) in the NCLB application and recorded in fund 20. The remainder of the school allocation should be blended in the school-based budget if the school has Title 1 schoolwide status.

Title I, Part D: *Prevention and Intervention Programs for Children and Youth who are Neglected, Delinquent, or At-Risk* is **NOT** blendable in a school-wide program. Districts should consult the schoolwide program resources referenced at the beginning of this section for guidance on which programs are blendable in a schoolwide program.

Step

Description

Title 1, Part A: Basic

- 1 Complete the Title 1 Eligibility page of the NCLB Consolidated Formula Subgrant Application as usual. This is done to determine which schools are eligible to receive Title I funding based upon the poverty level of the school.
- 2 Once the allocations to the schools are calculated on the Title 1 Eligibility page use the school allocations to determine the budgeted percentage of total resources Title I represents of each school's budget.
- 3 Determine the contracted teacher and administrator salaries in each school. This can be done by performing a payroll sort from the district's payroll system, by school, detailing the teachers at each school and each teacher's contracted salaries paid during the year. (This amount is to be contracted base wages only and should not include stipends or extra-curricular activity payments.)
- 4 Multiply the contracted teacher and administrator salaries determined in #3 above by the Title I resource percentage for that school determined in #2 above to determine the portion of contracted teacher and administrator salaries paid from Title I funds.
- 5 Multiply the federal contracted teacher and administrator salaries determined in #4 above by the TPAF, FICA and Medicare rates (use the fiscal year 2012 pension rate and calendar year 2012 FICA and Medicare rates because those are the only rates available at budget time) to determine the budgeted benefits reimbursement due to the State of New Jersey for the portion of that school's contracted teacher and administrator salaries attributable to Title I. The rates are as follows:

- 6 Add the TPAF, FICA and Medicare reimbursements calculated in #5 above together by school to determine the benefit reimbursements on a school level.

Step

Description

- 7 For each school, subtract the benefits reimbursements from #6 above out of the applicable school's allocation of funds determined in #1 above. The result of this is the amount of Title I funds to be sent to that school to be blended in the school-based budget and included on the School-wide Programs line (function/object 520-930) of the NCLB Consolidated Formula Subgrant Application – Budget Summary page. The school amount calculated in this step should be entered on line 00710 (Title I) in the revenues screen, for the applicable school, of the School-Based Budget Menu section of the district-wide budget software.
- 8 The amount included on line 520-930 for a particular school (#7 above) plus the benefit reimbursement for that school (#6 above) will equal the school's allocation determined in #1 above.
- 9 Summarize the school-level reimbursement calculations (#6 above) to determine the total reimbursement for all schools. Include this number on line 200-200 of the Budget Summary page of the NCLB LEA Consolidated Formula Subgrant Application in the Title I column. This amount must be broken out by school in the Program Coordination and Budget Detail pages of the NCLB Application.
- 10 Summarize the individual school contributions to the blended resource school-based budget (#7 above) to determine the total Title I contribution to the school-based budget. Include this number on line 520-930 of the Budget Summary page of the NCLB LEA Consolidated Formula Subgrant Application in the Title I column. This amount must be broken out by school in the Program Coordination and Budget Detail pages of the NCLB Application.

Other Federal funds eligible to be consolidated in a schoolwide program.

Other Federal program funds may also be blended in school-based budgets. Consult the schoolwide program reference materials included at the beginning of this section for which Federal revenues are permitted to be blended in a school-based budget. The TPAF, FICA and Medicare reimbursements to the State of New Jersey associated with the portion of contracted teacher and administrator salaries attributable to these funds need to be calculated and budgeted using the same procedures outlined above for Title I. Follow steps 3-10 above using the applicable funding source resource percentage for each federal funding source blended in each school-based budget.

Step

Description

The amount determined in Step 7 above should be included on the appropriate line of the school’s revenue screen in the district-wide budget software.

***Title I, Part A: School Improvement and Title I, Part D: Prevention and Intervention Programs for Children and Youth who are Neglected, Delinquent, or At-Risk are not to be blended in school-wide programs and therefore cannot be blended in a school-based budget.***

**E. PREPARATION OF THE SCHOOL-BASED BUDGET STATEMENT**

School-Based Budgets and District-wide Budget

Electronic Data Collection (EDC) of the 2012-13 annual school-based budget statement is required for all schools with blended resource school-based budgets in the district-wide budget software. The program generates the prescribed school-based budget reports, per pupil spending report, and comparison reports.

There are three screens included in the School-Based Budgets menu of the district-wide DOEnet budget software: Revenues, Detailed Appropriations, and Staffing. In 2012-13, districts must enter the school-based revenues, appropriations and staffing information directly into the district-wide budget software. Audited 2010-11 expenditure data will be loaded from Audsum. The 2011-12 original budget will be preloaded into the 2011-12 column for each school. Districts must update the amounts to the February 1, 2012 revised budget for each school.

School-Based Revenues

Original budget revenue data for 2011-12 will be preloaded into the 2011-12 column for each school. Districts must update this information to reflect the February 1, 2012 revised budget. The 2012-13 budget information must be manually entered by the district. The school-based budget revenue account grid follows this section.

### School-Based Appropriation Data

Audited expenditure data will be preloaded into the 2010-11 column for each school. Original budget appropriation data for 2011-12 will be preloaded into the 2011-12 column for each school. Districts must update this information to reflect the February 1, 2012 revised budget. The 2012-13 budget information must be manually entered by the district. The school-based budget appropriation account grid follows this section.

### Supporting Documentation Item 3

The 2011-12 and 2012-13 FTE data entered into Supporting Documentation Item #3 “Budgeted FTEs” should include FTEs for both fund 11 and fund 15 personnel, as a combined total for each account number.

### Supporting Documentation Item 7

The 2012-13 appropriation data for all schools is summarized by function and appears in a column labeled “2012-13 Approp. Sch-Based” in supporting documentation item 7. This column is necessary to provide the comparison of budgeted data since the general fund resources allocated to school-based budgets are included on one line (9466) – General Fund Contribution to School-Based Budgets. The software will sum the 2012-13 Appropriations Budgeted, the 2012-13 Separate Proposals, and the 2012-13 School-Based Budgets columns to calculate the 2012-13 Appropriations Total and that total will be used to calculate the dollar and percentage increase or decrease between 2011-12 and 2012-13.

### Advertised Blended Resource Statement

The school-based appropriations and revenues screens included in the budget software under the School-Based Budgets menu will generate the Advertised Blended Resource School-based Budget Statement. The advertised statement reflects summary totals of the revenues and appropriations reported in the school-based budgets.

## **E. District-Wide Reports for School-Based Budget Districts**

### Comparison Data Analysis Reports:

Additional analytical tools are included in the budget software for all districts completing school-based budgets to use in analyzing certain components in the proposed district-wide budget (Funds 11 & 12) compared to the current year district-wide budget (Funds 11 & 12). Items E-4 and E-5 below contain school-level information in addition to district-level information. The reports do not require any data entry; can be printed by accessing the School-Based Budgets Report Menu; and, are explained below in the order in which they appear on the School-Based Budgets Report Menu of the district-wide budget software. These reports must be printed and submitted with the 2012-13 district-wide budget.



#### E-1 Changes in Non-Instructional Costs in Fund 11

This report extracts data from non-instructional cost lines for the current and budget years from throughout the district-wide budget and calculates the dollar and percentage increases (decreases) associated with changes within the budget. The report details budget line number, line description, 2011-12 amount, 2012-13 amount, dollar increase (decrease) from 2011-12 to 2012-13 and percentage increase (decrease) from 2011-12 to 2012-13. The software will calculate totals for each column of the report.

#### E-2 Changes in Special Education Costs

This report extracts special education cost data for the current year and the budget year from throughout the district-wide budget (Fund 11 & 12) and calculates the dollar and percentage increases (decreases) associated with changes within the budget. The report details budget line number, line description, 2011-12 amount, 2012-13 amount, dollar increase (decrease) from 2011-12 to 2012-13 and percentage increase (decrease) from 2011-12 to 2012-13. The data within this report is identified in three categories, In-district Special Education Instruction Costs, Undistributed Expenditures – Instruction, and Equipment. The software will calculate totals for each column within each category and then a grand total for the entire report.

#### E-3 Total Amount of Non-Instructional Equipment

This report extracts non-instructional equipment cost data for the current year and the budget year from throughout the district-wide budget (Fund 12) and calculates the dollar and percentage increases (decreases) associated with the changes within the budget. The report details budget line number, line description, 2011-12 amount, 2012-13 amount, dollar increase (decrease) from 2011-12 to 2012-13 and percentage increase (decrease) from 2011-12 to 2012-13. The software will calculate totals for each column of the report.

#### E-4 Changes in Salaries and Benefit Costs

This report extracts salary and related benefit cost data for the current year and the budget year from throughout the district-wide budget (Fund 11, 12 & 13) and school-based budgets (Fund 15) and calculates the dollar and percentage increases (decreases) associated with changes within the budget. The report details budget line number, line description, 2011-12 amount, 2012-13 amount, dollar increase (decrease) from 2011-12 to 2012-13 and percentage increase (decrease) from 2011-12 to 2012-13. The percentage increase (decrease) from 2011-12 to 2012-13 on this report is programmed to default to 100% if the increase or decrease is greater than 100%. The software will calculate totals for each column within each category.

E-5 Changes in All Other Costs (Purchased Services, Supplies, Equipment, Tuition and Other Non-Salary Costs)

This report extracts cost data for the current year and the budget year from throughout the district-wide budget (Fund 10, 11, 12 & 13) and school-based budgets (Fund 15) and calculates the dollar and percentage increases (decreases) associated with changes within the budget. The report details budget line number, line description, 2011-12 amount, 2012-13 amount, dollar increase (decrease) from 2011-12 to 2012-13 and percentage increase (decrease) from 2011-12 to 2012-13. The data within this report is identified in four categories: Purchased Services and Supplies; Capital Outlay and Equipment; Tuition; and Other Non-Salary Costs. The percentage increase (decrease) from 2011-12 to 2012-13 on this report is programmed to default to 100% if the increase or decrease is greater than 100%. The software will calculate totals for each column within each category.
