## **SYNOPSIS**

Petitioner, a tenured clerk of respondent Board, along with her union, appealed the withholding of her increment for the 1997-98 school year.

After an Initial Decision was issued, the Commissioner remanded this matter to OAL for briefing and argument on the issue of jurisdiction, and for additional fact-finding, as necessary upon the exploration of such jurisdictional issues, in order to resolve this matter. The ALJ concluded that there is no statutory authority for the Commissioner to act on the increment withholding of nonteachers. Thus, the OAL has no jurisdiction over this matter. Petition was dismissed.

The Commissioner affirmed the opinion of the ALJ for the reasons set forth therein.
