SYNOPSIS

Petitioner challenged a disciplinary suspension imposed upon her during her senior year of high school, in the aftermath of an altercation with another student. Petitioner was readmitted to school following her suspension, went on to graduate in June 2009, and is currently on active duty in the United States Marine Corps. The school district contends that the issues raised in the petition have been rendered moot by Ms. Robinson's graduation, and asks that the matter be dismissed.

The ALJ found, *inter alia*, that: the claims raised in the petition are moot, as petitioner has already received her high school diploma and there is no longer any record of the suspension maintained in petitioner's student records; petitioner's assertions that the suspension was imposed in violation of her due process rights and that the district's disciplinary procedures are legally flawed are likewise moot because petitioner is no longer subject to the force of school procedures or regulations; and petitioner's argument that her within claims require resolution so that she may pursue claims against the district elsewhere is flawed as dismissal here does not preclude petitioner from later bringing her defamation and other claims before the appropriate court. Accordingly, the ALJ concluded that the petition should be dismissed.

Upon full consideration, the Commissioner concurred with the ALJ for the reasons comprehensively detailed in the Initial Decision, and dismissed the petition as moot.

The record of this matter and the Initial Decision of the Office of Administrative Law (OAL) have been reviewed.
