SUBJECT: Recovery High School Funding Opportunity

The New Jersey Department of Education (NJDOE) is seeking applications for funding to increase access for students in recovery to rigorous academic instruction and treatment provided by existing, public recovery high schools. For the purposes of this *Recovery High School Access Project*, a recovery high school program means "an alternative education program that serves students diagnosed with substance use disorder or dependency as defined by the most recent Diagnostic and Statistical Manual of Mental Disorders, and that provides a comprehensive four-year high school education in an alternative public school setting and a structured plan of recovery that is aligned with the national framework of evidence-based practices for recovery high schools (*N.J.S.A* 18A:35-30)." Recovery high schools facilitate a smooth transition from treatment to innovative, safe and supportive academic environments, where the goal is to prevent relapse and prepare students to graduate and achieve success after high school.

Two New Jersey public recovery high schools will receive awards through the *Recovery High School Access Project*. Allowable costs for each program will include tuition and transportation costs for up to 30 students and one full-time transition/re-entry counselor with expertise in addiction treatment. Tuition may be prorated for students who do not attend for the full project period. Students, ages 14-21, who have been diagnosed with a substance abuse or dependency disorder, and who are seeking a sober lifestyle, will be eligible for the program.

The project period will begin immediately upon approval from the NJDOE and run through June 30, 2018. The project period may be extended depending upon availability of funds. Each applicant must provide assurances that recovery high school courses and program components are aligned with the New Jersey Student Learning Standards and prepare students to meet New Jersey's graduation requirements in accordance with New Jersey Administrative Code, Title 6A, Chapter 8 (*N.J.A.C.* 6A:8). Applicants must also commit to accepting students from surrounding communities and counties. Each application must demonstrate that the appropriate partnerships are in place with addiction and recovery services in the community where the program is located, as well as the communities where students reside, to support students and their families beyond the school day. Award recipients must engage in collaborative activities with each other to maximize student success and family engagement.
