There were 194 Salem County residents who went through the Intoxicated Driver Resource Center program in 2007. The following tables and graphs give demographic information about these clients. Clients' reported alcohol and other drug use characteristics are also described. Information was gathered from a mandatory self-administered questionnaire given during the IDRC classes and the counselors' screening/scoring scoring forms.
