

2010 MERCER COUNTY INTOXICATED DRIVING RESOURCE CENTER STATISTICAL QUICK SHEET

Data were collected on 791 clients in 2010 who went through the Mercer County Intoxicated Driver Resource Center program or were monitored by the Mercer County IDRC. 











Lifetime Marijuana, Cocaine and Heroin Use by Mercer County IDRC Clients Compared with 2009 NJ Household Survey



2010 Mercer County Resident Referrals from IDRC




