Accreditation Status

INSTITUTIONAL ACCREDITATION

Gloucester County College has been accredited by the Commission on Higher Education – Middle States Association of Colleges and Schools since 1973. Accreditation was reaffirmed in 1977, 1987, and 1998. The college recently completed their decennial self-study review and accreditation was reaffirmed on June 26, 2008. The College is a member of the New Jersey Association of Colleges and Universities and the American Association of Community Colleges.

PROFESSIONAL ACCREDITATION

The Nursing program is accredited by the National League for Nursing Accrediting Commission (NLNAC). The Respiratory Therapy Program is accredited by the Committee on Accreditation for Respiratory Care. The Diagnostic Medical Sonography (DMS) Program is accredited by the Joint Review Committee on Education in Diagnostic Medical Sonography (JRC-DMS). The Nuclear Medicine Technology (NMT) Program is accredited by the Joint Review Committee on Educational Programs in Nuclear Medicine Technology (JRC-NMT) and the New Jersey Environmental Protection Agency Bureau of Radiologic Health. In addition, the DMS and NMT Programs are accredited through the Commission on Accreditation of Allied Health Educational Programs (CAAHEP).

Gloucester County College's Paralegal Program degree program and certificate program are both accredited by the American Bar Association.











DISTRIBUTION OF STUDENTS BY AGE


