Equipment Distribution Program

The **Equipment Distribution Program** provides telecommunications and home safety equipment at no cost to eligible people who are deaf and hard of hearing. Eligibility requirements are :

- Must be a New Jersey resident
- Must have a hearing loss
- Household income less than \$45,000

The New Jersey Division of the Deaf and Hard of Hearing has a vacancy for a Hard of Hearing Specialist. The position will be assigned to working with people who are hard of hearing and late deafened including senior citizens.

The candidate will strive to improve the quality of life for people with hearing loss in the home, workplace and community. Job functions include taking on a leadership role in operating programs offered by the Division including:

- NJ Reconditioned Hearing Aid Program
- Assistive Listening Device Loan Library
- Hearing Loss Awareness Training
- Assistive Communication Device Demonstration Centers

The candidate will conduct community outreach efforts to enhance public awareness of hearing loss including working with County Offices on Aging, over 55 communities and senior citizens. Must have a thorough knowledge of assistive technology devices and state-wide resources and services for people with hearing loss.
