## 2018 Directory of CART Reporters

Dear Consumer:

Attached is the NJ Division of the Deaf and Hard of Hearing's (DDHH) referral list containing contact information for CART reporters. CART is a reasonable accommodation under the Americans with Disabilities Act (ADA) for persons with hearing loss. DDHH disseminates this list as a service to the community and as a resource for consumers to locate and hire CART reporters.

DDHH is unable to make any claim as to the skills of any CART reporters for a specific assignment. Consumers are reminded that each CART reporter functions as a business entity. When hiring a CART reporter, the consumer is strongly encouraged to become familiar with the respective CART reporter's business policies (i.e. fees, payment, cancellation of services, etc.).

CART stands for "communication access realtime translation". This service is provided by a trained individual, called a realtime or court reporter that operates a stenotype machine which is linked to a computer. The reporter types as words are spoken, producing a verbatim transcript, and the text appears on the computer monitor, television, projection screen, or other related equipment.
