DIVISION OF FAMILY DEVELOPMENT CURRENT PROGRAM STATISTICS APRIL 2019

Each month the Division of Family Development publishes its program statistics for: WFNJ/TANF, NJ SNAP, Emergency Assistance, General Assistance, and Child Support Services. When possible, information is provided separately for children and adults. Many tables also provide trend data with information broken down by county for readers to consider. This report is compiled and prepared by The Bureau of Research & Reporting.

WFNJ/TANF

- As of the end of April, the TANF caseload had decreased by 2,958 cases, from 13,788 in April 2018 to 10,830 in April 2019, a decrease of 21.5%.
- The counties with caseloads that decreased the most since April 2018 were Passaic (-24.8%), Cumberland (-26.5%) and Atlantic (-32.8%).
- Of the WFNJ/TANF cases, 3,906 or 36.1% were child-only in April 2019.
- The counties with the most child-only cases were Camden (636), Essex (519) and Passaic (406).
- Essex (4,693), Camden (3,585), Hudson (3,325), Passaic (3,082) and Atlantic (1,717) counties had the greatest number of persons receiving TANF in April 2019.

NJ SNAP (formerly FOOD STAMPS)

- In April 2019, there were 346,955 households receiving NJ SNAP benefits. The number of NJ SNAP households decreased by 26,217 or 7.0%, since April 2018.
- There were 686,728 persons receiving NJ SNAP benefits as of April 2019, a decrease of 54,748 or 7.6% since April 2018.
- The counties having the highest caseload decrease since April 2018 are Hudson (-8.5%), Somerset (-11.0%) and Atlantic (-12.9%).

EMERGENCY ASSISTANCE

- There were 1,546 TANF families receiving Emergency Assistance (EA) in April 2019, a decrease of 249 or 13.9% since April 2018.
- In April 2019, EA payments were made for 474 SSI recipients.

DIVISION OF FAMILY DEVELOPMENT CURRENT PROGRAM STATISTICS APRIL 2019

- There were 2,165 GA cases with Emergency Assistance payments in April 2019, a decrease of 51 or 2.3% since April 2018.
 - The counties that showed the highest percent increase in Emergency Assistance payments were Warren (71.0%), Monmouth (93.3%) and Cumberland (166.7%).
 - The counties that showed the highest percent decrease in Emergency Assistance payments were Cape May (-25.0%), Ocean (-31.1%) and Salem (-76.5%).

GENERAL ASSISTANCE

- The total numbers of cases receiving GA has decreased from 12,396 to 10,475 since April 2018, a decrease of 15.5%.
- There were 4,225 Employable GA and 6,250 Unemployable GA cases in April 2019.
- The counties that showed a percent increase for GA cases were Hunterdon (10.4%), Warren (12.0%) and Monmouth (23.4%) since April 2018.
- The counties that showed the highest percent decrease for GA cases since April 2018 were Camden (-23.0%), Cape May (-24.1%) and Atlantic (-28.6%).
- In April 2019, GA cases showed a 0.1% decrease since March 2019.

CHILD SUPPORT SERVICES (Quarterly Report)

- The total collection for the Child Support Services Program was about \$312 million from January 2019 to March 2019, a decrease of 1.0 percent over the same period for FFY 2018.
- Total distributions decreased 1.3% from March 2018.


WORK FIRST NEW JERSEY (WFNJ)

- During the report month of April 2019, there were 963 families in which at least one member was employed and an additional 207 families whose WFNJ assistance cases were closed due to employment related earnings.
- The three counties with the greatest number of employed active WFNJ recipients were: Essex (215), Camden (138) and Hudson (98).





Work Participation Rates Achieved Over 12 Month Period Ending With APRIL 2019








ACRONYMS

EMERGENCY ASSISTANCE (EA) - Payments to those eligible for WFNJ/TANF or WFNJ/GA, authorized during the 30 consecutive days immediately following the emergency (defined as a substantial loss of shelter, food, clothing, or household furnishings by fire, flood or other similar disaster) or if eligible individual or family is an imminent or actual state of homelessness.

NJ SNAP - Formerly the Food Stamp Program, now known as **NJ SNAP** (NJ Supplemental Nutrition Assistance Program) authorized by Congress as a nutritional supplement program to provide low income households with more food of greater variety and better nutrition. Program eligibility is based on household income, resources, and expenses for medical, shelter, and dependent care. CWA staff refers certain recipients to the New Jersey Department of Labor for participation in the Food Stamp Employment and Training Program.

FAMIS: Family Assistance Management Information System

GAAS: General Assistance Automated System

NJKiDS: New Jersey Kids Deserve Support (Child Support Information Management System)

NJ MMIS SHARED DATA WAREHOUSE: The Shared Data Warehouse (SDW) is the repository for New Jersey's DFD and Medicaid data. Since 2003, OptumInsight has administered the SDW and provided access to the data through a reporting tool known as Business Objects.

OMEGA: Online Management of Economic Goal Achievement

SSI-EA: Supplemental Security Income-Emergency Assistance

WFNJ: Work First New Jersey - Fully implemented July 1, 1997, this is New Jersey's welfare reform program which responds to the requirements of the Federal Personal Responsibility and Work Opportunity Reconciliation Act (**PRWORA**) of 1996. PRWORA established Temporary Assistance for Needy Families (**TANF**) as the replacement for AFDC cash assistance. WFNJ includes two segments, **WFNJ/TANF** for families with children, and **WFNJ/GA** (General Assistance) for single adults and couples without dependent children. WFNJ emphasizes achieving self-sufficiency and limits lifetime receipt of financial assistance to a total of five years.
