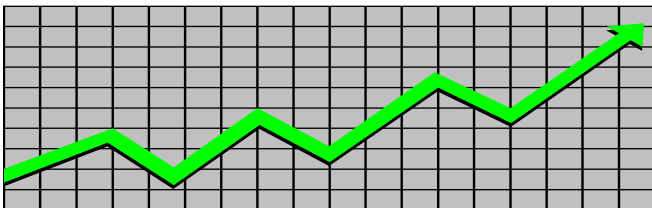

**DIVISION OF FAMILY DEVELOPMENT CURRENT PROGRAM STATISTICS
NOVEMBER 2011**

Each month the Division of Family Development publishes its program statistics for: WFNJ/TANF, NJ SNAP, Emergency Assistance, General Assistance, and Child Support Services. When possible, information is provided separately for children and adults. Many tables also provide trend data with information broken down by county for readers to consider. This report is compiled and prepared by The Bureau of Research & Statistics.

WFNJ/TANF

- As of the end of November, the TANF caseload had increased by 447 cases, from 40,752 in November 2010 to 41,199 in November 2011, a 1.1% increase.
- The counties with the highest family caseload percentage increase since November 2010 include Passaic (15.7%), Hunterdon (11.1%), and Ocean (10.2%).
- The counties with caseloads that decreased since November 2010 were Cumberland (-7.8%), Sussex (-8.2%), and Monmouth (-9.2%).
- Of the WFNJ/TANF cases, 8,977 or 21.8% were child-only in November 2011.
- The counties with the most child-only cases were Essex (1,478), Hudson (1,168), and Camden (1,137).
- Essex (22,710), Hudson (12,224), and Passaic (12,127) counties had the greatest number of persons receiving TANF in November 2011.

NJ SNAP (formerly FOOD STAMPS)

- In November 2011, there were 386,177 households receiving NJ SNAP benefits. The number of NJ SNAP households increased by 43,673, or 12.8%, since November 2010.
- There were 783,224 persons receiving NJ SNAP benefits as of November 2011, an increase of 86,503 or 12.4% since November 2010.
- The three counties having the highest caseload increase since November 2010 are Atlantic (32.4%), Passaic (22.5%), and Hunterdon (18.3%).

EMERGENCY ASSISTANCE

- There were 7,074 families receiving Emergency Assistance (EA) in November 2011, an increase of 631 or 9.8% since November 2010.
- In November 2011, EA payments were made for 1,521 SSI recipients.

GENERAL ASSISTANCE

GA Emergency Assistance

- There were 7,158 Emergency Assistance payments made to GA cases in November 2011, a decrease of 856 or 10.7% since November 2010.
- The three counties that show an annual percent increase in emergency assistance payments are Passaic (43.3%), Mercer (24.3%), and Monmouth (15.3%).

GA Program

- The total numbers of cases receiving GA has decreased from 53,685 to 45,121 since November 2010, a decrease of 16.0%.
- There were 31,652 Employable GA and 13,469 Unemployable GA cases in November 2011.
- Gloucester County showed a 2.0 percent increase for GA cases since November 2010.

CHILD SUPPORT SERVICES (Quarterly Report)

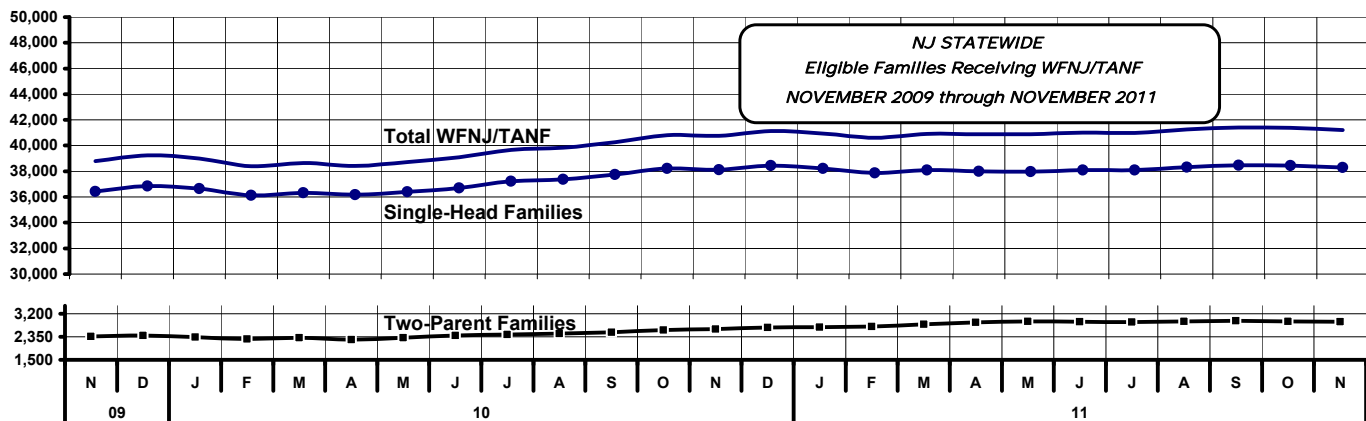
- The total collection for the Child Support Services Program was about \$305 million from July 2010 to September 2011, an increase of 2.2 percent over the same period for FFY 2010.
- Total distributions increased over 2.3% from September 2010.

WORK FIRST NEW JERSEY (WFNJ)

- During the report month of November 2011, there were 4,570 families in which at least one member was employed and an additional 565 families whose WFNJ assistance cases were closed due to employment - related earnings.
- The three counties with the greatest number of employed active WFNJ recipients were: Essex (1,107), Hudson (602), and Camden (491).
- There were 2,931 former TANF cases receiving post-TANF support in the form of child care assistance.

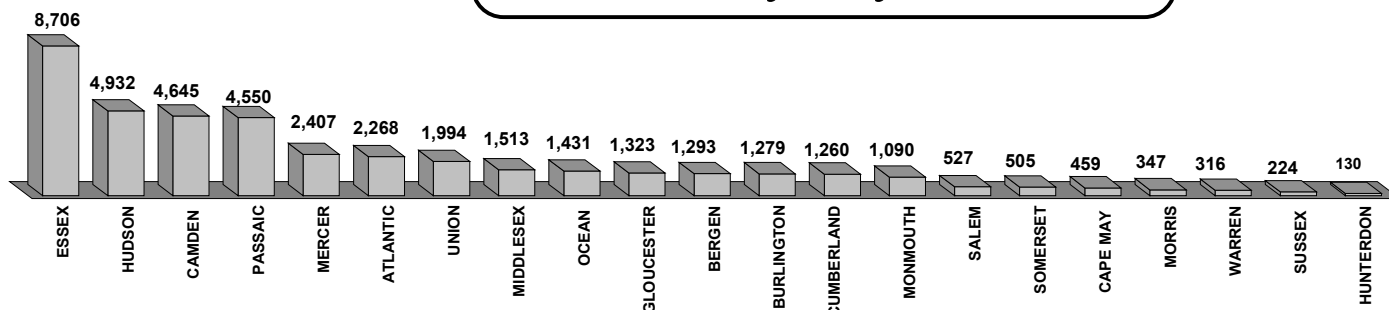

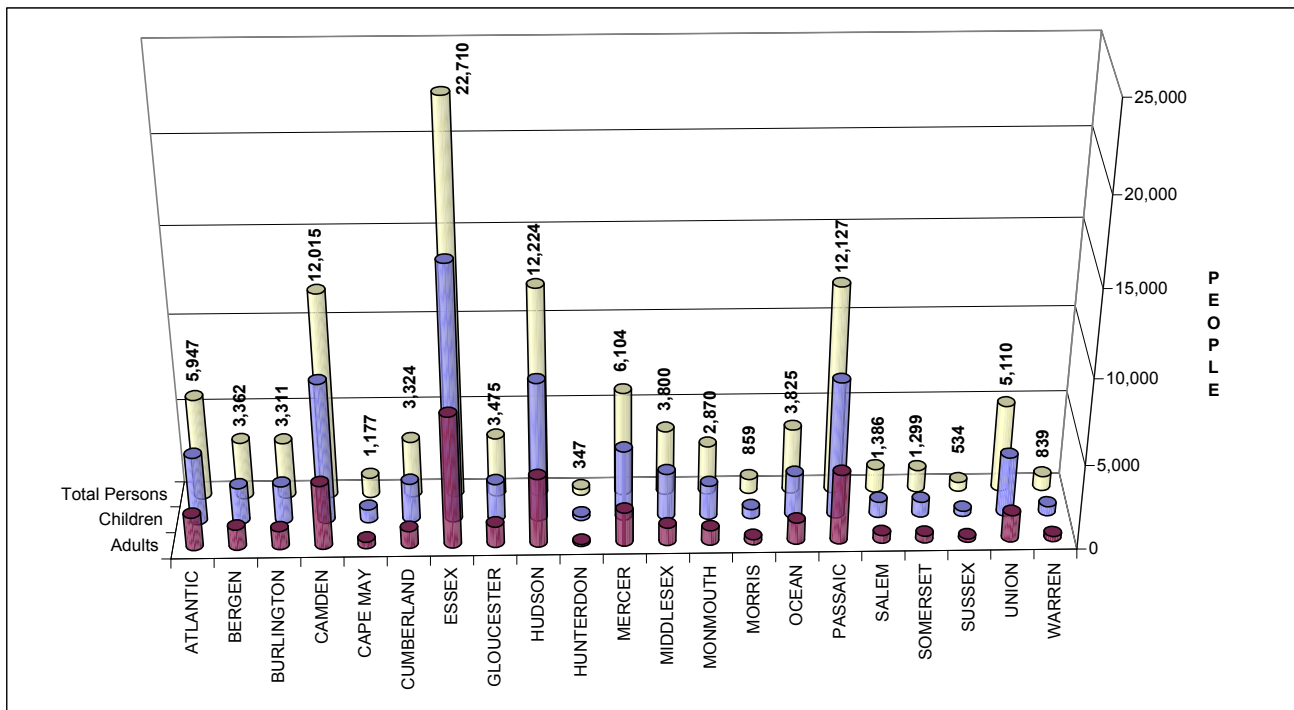

Ending With NOVEMBER 2011**

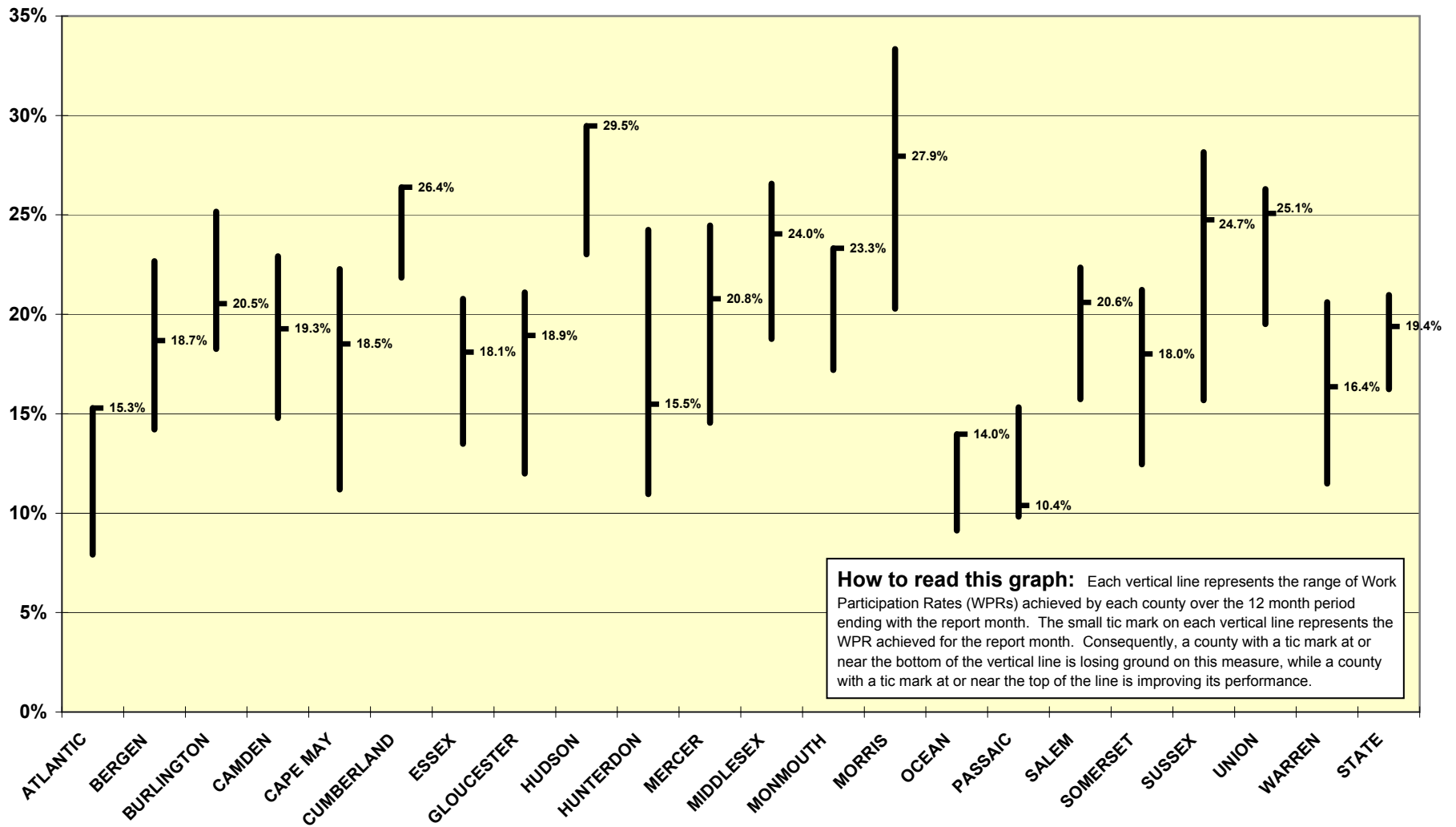
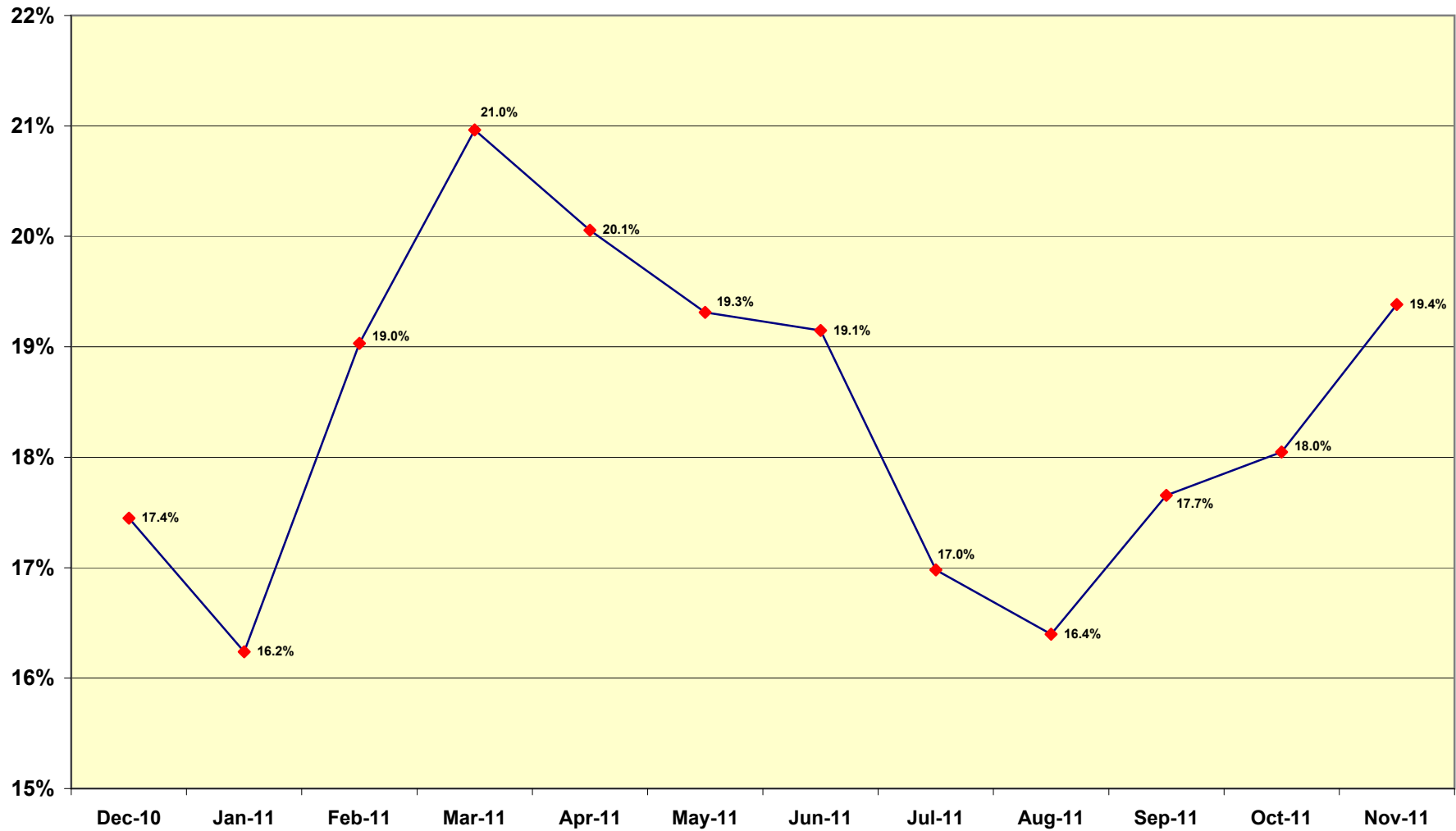

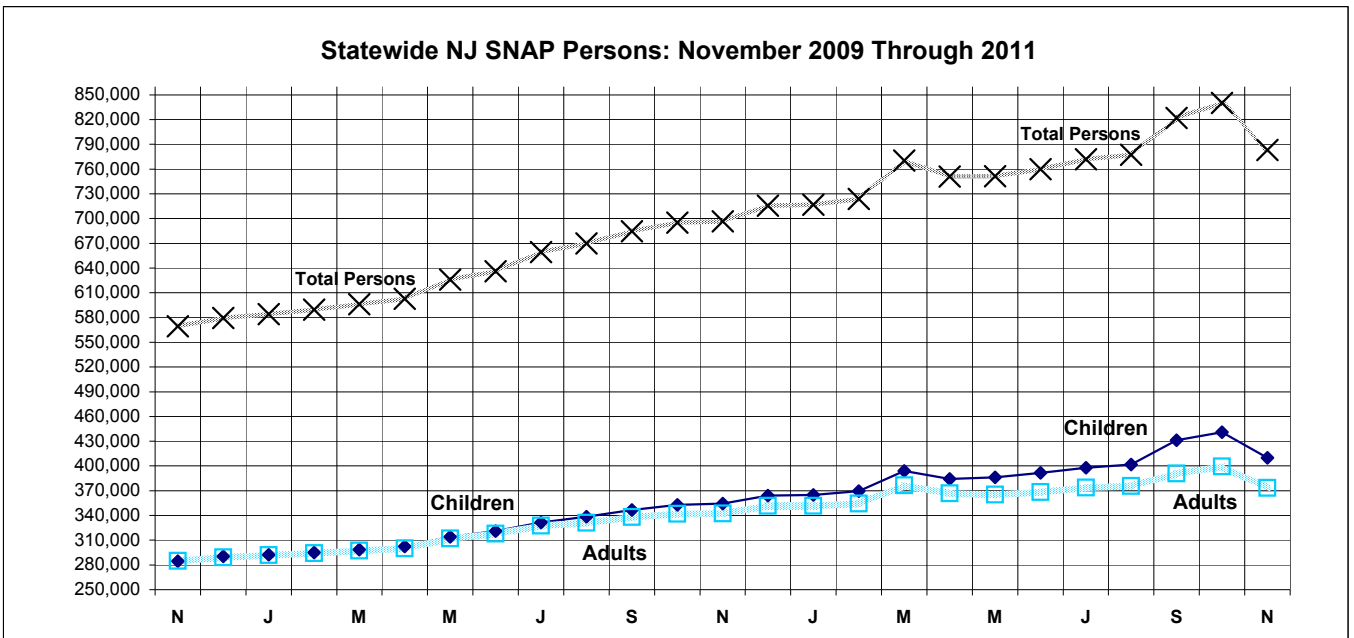

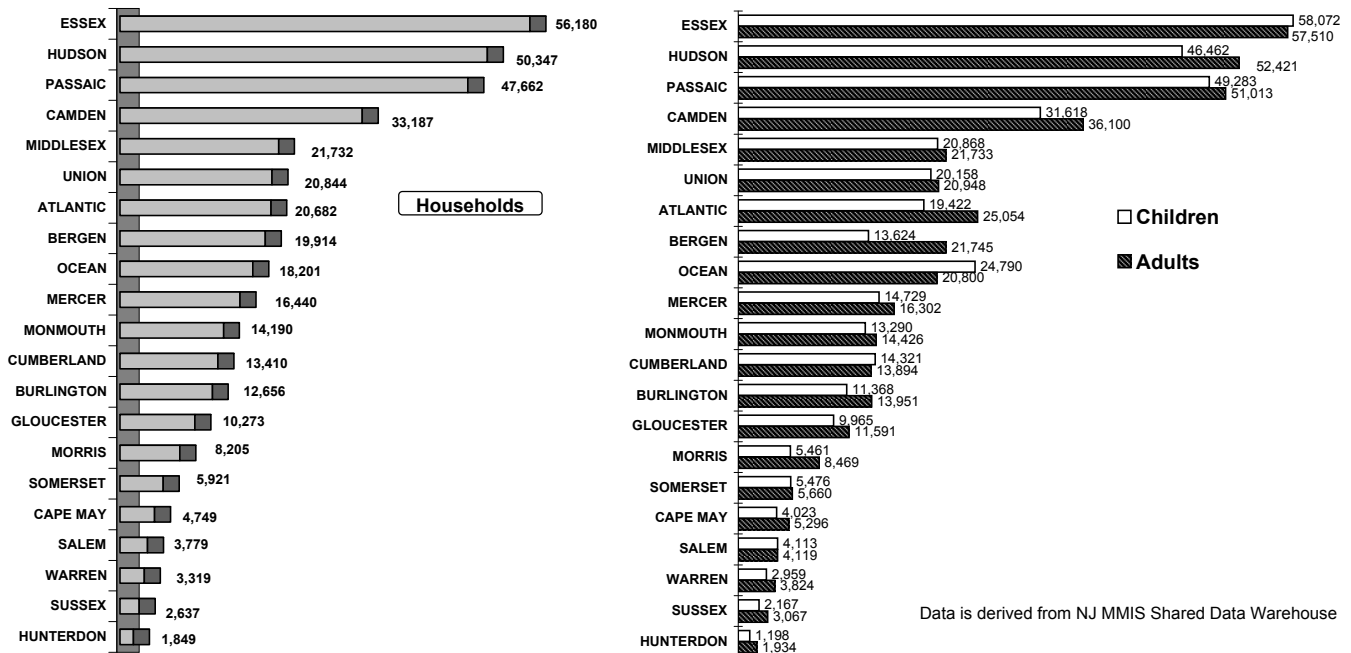

ACRONYMS

CASS: Consolidated Assistance and Support System

EMERGENCY ASSISTANCE (EA) - Payments to those eligible for WFNJ/TANF or WFNJ/GA, authorized during the 30 consecutive days immediately following the emergency (defined as a substantial loss of shelter, food, clothing, or household furnishings by fire, flood or other similar disaster) or if eligible individual or family is in an imminent or actual state of homelessness.

NJ SNAP - Formerly the Food Stamp Program, now known as **NJ SNAP** (NJ Supplemental Nutrition Assistance Program) authorized by Congress as a nutritional supplement program to provide low income households with more food of greater variety and better nutrition. Program eligibility is based on household income, resources, and expenses for medical, shelter, and dependent care. CWA staff refers certain recipients to the New Jersey Department of Labor for participation in the Food Stamp Employment and Training Program.

FAMIS: Family Assistance Management Information System

GAAS: General Assistance Automated System

NJKIDS: New Jersey Kids Deserve Support (Child Support Information Management System)

NJ MMIS SHARED DATA WAREHOUSE: The Shared Data Warehouse (SDW) is the repository for New Jersey's DFD and Medicaid data. Since 2003, OptumInsight has administered the SDW and provided access to the data through a reporting tool known as Business Objects.

OMEGA: Online Management of Economic Goal Achievement

SSI-EA: Supplemental Security Income-Emergency Assistance

WFNJ: Work First New Jersey - Fully implemented July 1, 1997, this is New Jersey's welfare reform program which responds to the requirements of the Federal Personal Responsibility and Work Opportunity Reconciliation Act (**PRWORA**) of 1996. PRWORA established Temporary Assistance for Needy Families (**TANF**) as the replacement for AFDC cash assistance. WFNJ includes two segments, **WFNJ/TANF** for families with children, and **WFNJ/GA** (General Assistance) for single adults and couples without dependent children. WFNJ emphasizes achieving self-sufficiency and limits lifetime receipt of financial assistance to a total of five years.
