Each month the Division of Family Development publishes its program statistics for: WFNJ/TANF, NJ SNAP, Emergency Assistance, General Assistance, and Child Support Services. When possible, information is provided separately for children and adults. Many tables also provide trend data with information broken down by county for readers to consider. This report is compiled and prepared by The Bureau of Research & Reporting.

WFNJ/TANF

- As of the end of October, the TANF caseload had decreased by 1,650 cases, from 41,371 in October 2011 to 39,721 in October 2012, a decrease of 4.0%.
- The counties with the highest family caseload percentage increase since October 2011 include Passaic (6.8%), Warren (5.8%), and Ocean (2.7%).
- The counties with caseloads that decreased since October 2011 were Morris (-12.3%), Burlington (-13.7%), and Hunterdon (-17.6%).
- Of the WFNJ/TANF cases, 8,281 or 20.8% were child-only in October 2012.
- The counties with the most child-only cases were Essex (1,355), Camden (1,115), and Hudson (1,034).
- Essex (21,353), Passaic (12,749), and Camden (11,806) counties had the greatest number of persons receiving TANF in October 2012.

NJ SNAP (formerly FOOD STAMPS)

- In October 2012, there were 419,617 households receiving NJ SNAP benefits. The number of NJ SNAP households increased by 8,763, or 2.1%, since October 2011.
- There were 843,107 persons receiving NJ SNAP benefits as of October 2012, an increase of 2,718 or 0.3% since October 2011.
- The three counties having the highest caseload increase since October 2011 are Monmouth (15.4%), Middlesex (10.4%), and Essex (7.0%).

EMERGENCY ASSISTANCE

- There were 6,503 families receiving Emergency Assistance (EA) in October 2012, a decrease of 745 or 10.3% since October 2011.
- In October 2012, EA payments were made for 1,632 SSI recipients.

GENERAL ASSISTANCE

GA Emergency Assistance

- There were 6,646 Emergency Assistance payments made to GA cases in October 2012, a decrease of 713 or 9.7% since October 2011.
- The three counties that show an annual percent increase in emergency assistance payments are Cumberland (43.1%), Middlesex (27.3), and Ocean (22.5%).

GA Program

- The total numbers of cases receiving GA has decreased from 46,287 to 41,559 since October 2011, a decrease of 10.2%.
- There were 28,399 Employable GA and 13,160 Unemployable GA cases in October 2012.
- In October 2012, GA cases showed a 1.2 percent decrease since September 2012.

CHILD SUPPORT SERVICES (Quarterly Report)

- The total collection for the Child Support Services Program was about \$305 million from July 2012 to September 2012, a decrease of 1 percent over the same period for FFY 2011.
- Total distributions increased over 0.1% from September 2011.


WORK FIRST NEW JERSEY (WFNJ)

- During the report month of October 2012, there were 4,588 families in which at least one member was employed and an additional 587 families whose WFNJ assistance cases were closed due to employment related earnings.
- The three counties with the greatest number of employed active WFNJ recipients were: Essex (1,056), Hudson (541), and Camden (517).







Work Participation Rates Achieved Over 12 Month Period Ending With OCTOBER 2012




ACRONYMS

CASS: Consolidated Assistance and Support System

EMERGENCY ASSISTANCE (EA) - Payments to those eligible for WFNJ/TANF or WFNJ/GA, authorized during the 30 consecutive days immediately following the emergency (defined as a substantial loss of shelter, food, clothing, or household furnishings by fire, flood or other similar disaster) or if eligible individual or family is an imminent or actual state of homelessness.

NJ SNAP - Formerly the Food Stamp Program, now known as **NJ SNAP** (NJ Supplemental Nutrition Assistance Program) authorized by Congress as a nutritional supplement program to provide low income households with more food of greater variety and better nutrition. Program eligibility is based on household income, resources, and expenses for medical, shelter, and dependent care. CWA staff refers certain recipients to the New Jersey Department of Labor for participation in the Food Stamp Employment and Training Program.

FAMIS: Family Assistance Management Information System

GAAS: General Assistance Automated System

NJKiDS: New Jersey Kids Deserve Support (Child Support Information Management System)

NJ MMIS SHARED DATA WAREHOUSE: The Shared Data Warehouse (SDW) is the repository for New Jersey's DFD and Medicaid data. Since 2003, OptumInsight has administered the SDW and provided access to the data through a reporting tool known as Business Objects.

OMEGA: Online Management of Economic Goal Achievement

SSI-EA: Supplemental Security Income-Emergency Assistance

WFNJ: Work First New Jersey - Fully implemented July 1, 1997, this is New Jersey's welfare reform program which responds to the requirements of the Federal Personal Responsibility and Work Opportunity Reconciliation Act (PRWORA) of 1996. PRWORA established Temporary Assistance for Needy Families (TANF) as the replacement for AFDC cash assistance. WFNJ includes two segments, WFNJ/TANF for families with children, and WFNJ/GA (General Assistance) for single adults and couples without dependent children. WFNJ emphasizes achieving self-sufficiency and limits lifetime receipt of financial assistance to a total of five years.

EXPLANATORY NOTES

The Department of Human Services Division of Family Development provides basic income and an opportunity to achieve self-sufficiency for individuals and families served by the Division's programs. The Division provides leadership, direction and supervision to those public agencies responsible for administering those programs and plans for and develops policies to promote self-sufficiency.
