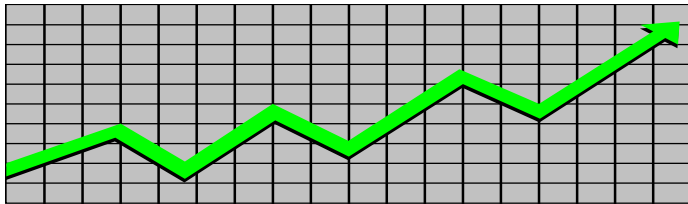

**DIVISION OF FAMILY DEVELOPMENT CURRENT PROGRAM STATISTICS
OCTOBER 2018**

Each month the Division of Family Development publishes its program statistics for: WFNJ/TANF, NJ SNAP, Emergency Assistance, General Assistance, and Child Support Services. When possible, information is provided separately for children and adults. Many tables also provide trend data with information broken down by county for readers to consider. This report is compiled and prepared by The Bureau of Research & Reporting.

WFNJ/TANF

- As of the end of October, the TANF caseload had decreased by 3,015 cases, from 15,476 in October 2017 to 12,461 in October 2018, a decrease of 19.5%.

- The county where the family caseload percentage increased since October 2017 was Hunterdon (3.8%).

- The counties with caseloads that decreased the most since October 2017 were Atlantic (-26.6%), Sussex (-27.8%) and Passaic (-28.3%).

- Of the WFNJ/TANF cases, 4,222 or 33.9% were child-only in October 2018.

- The counties with the most child-only cases were Camden (674), Essex (577) and Hudson (451).

- Essex (5,448), Camden (4,071), Hudson (3,831), Passaic (3,522) and Atlantic (2,085) counties had the greatest number of persons receiving TANF in October 2018.

NJ SNAP (formerly FOOD STAMPS)

- In October 2018, there were 362,885 households receiving NJ SNAP benefits. The number of NJ SNAP households decreased by 22,339 or 5.8%, since October 2017.

- There were 721,848 persons receiving NJ SNAP benefits as of October 2018, a decrease of 44,453 or 5.8% since October 2017.

- The county showing a caseload increase since October 2017 was Cumberland (0.1%).

- The counties having the highest caseload decrease since October 2017 are Atlantic (-9.6%), Ocean (-10.2%) and Sussex (-10.9%).

EMERGENCY ASSISTANCE

- There were 1,622 TANF families receiving Emergency Assistance (EA) in October 2018, a decrease of 245 or 13.1% since October 2017.

- In October 2018, EA payments were made for 472 SSI recipients.

- There were 1,988 GA cases with Emergency Assistance payments in October 2018, a decrease of 277 or 12.2% since October 2017.
- The counties that showed the highest percent increase in Emergency Assistance payments were Warren (25.0%), Monmouth (31.3%) and Middlesex (74.1%).
- The counties that showed the highest percent decrease in Emergency Assistance payments were Essex (-33.9%), Cape May (-34.3%) and Salem (-61.5%).

GENERAL ASSISTANCE

- The total numbers of cases receiving GA has decreased from 13,339 to 11,301 since October 2017, a decrease of 15.3%.
- There were 4,478 Employable GA and 6,823 Unemployable GA cases in October 2018.
- The counties that showed a percent increase for GA cases were Somerset (4.9%), Hunterdon (13.9%) and Monmouth (16.3%) since October 2017.
- The counties that showed the highest percent decrease for GA cases since October 2017 were Atlantic (-21.0%), Burlington (-21.2%) and Sussex (-26.8%).
- In October 2018, GA cases showed a 0.1% decrease since September 2018.

CHILD SUPPORT SERVICES (Quarterly Report)

- The total collection for the Child Support Services Program was about \$298 million from July 2018 to September 2018, a decrease of 1.6 percent over the same period for FFY 2017.
- Total distributions decreased 2.6% from September 2017.

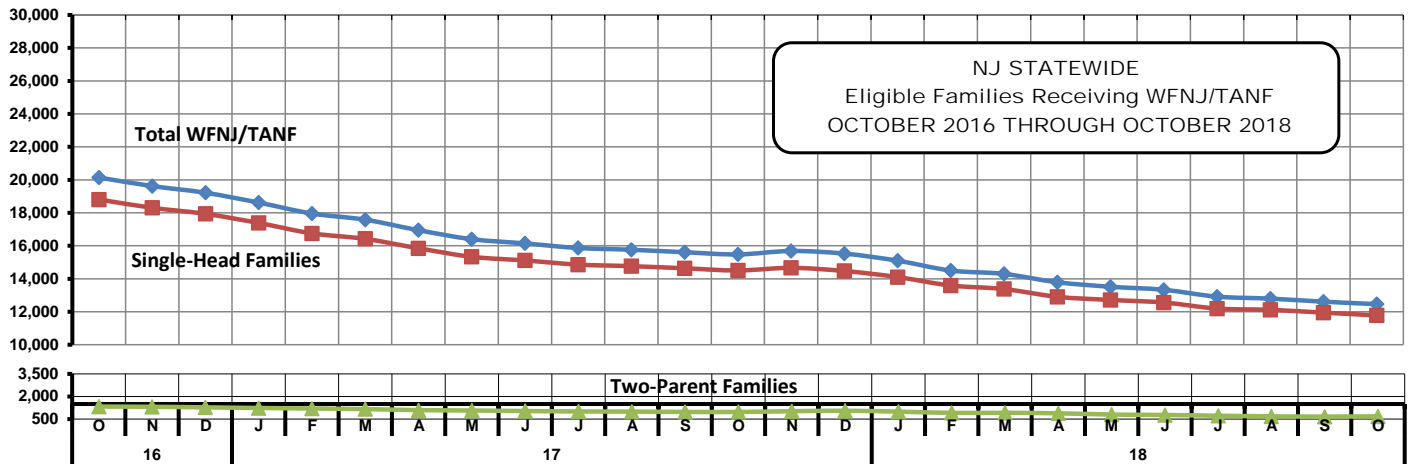
WORK FIRST NEW JERSEY (WFNJ)

- During the report month of October 2018, there were 1,390 families in which at least one member was employed and an additional 196 families whose WFNJ assistance cases were closed due to employment - related earnings.
- The three counties with the greatest number of employed active WFNJ recipients were: Essex (326), Camden (193) and Atlantic (146).
- There were 1,531 former TANF cases receiving post-TANF support in the form of child care assistance.

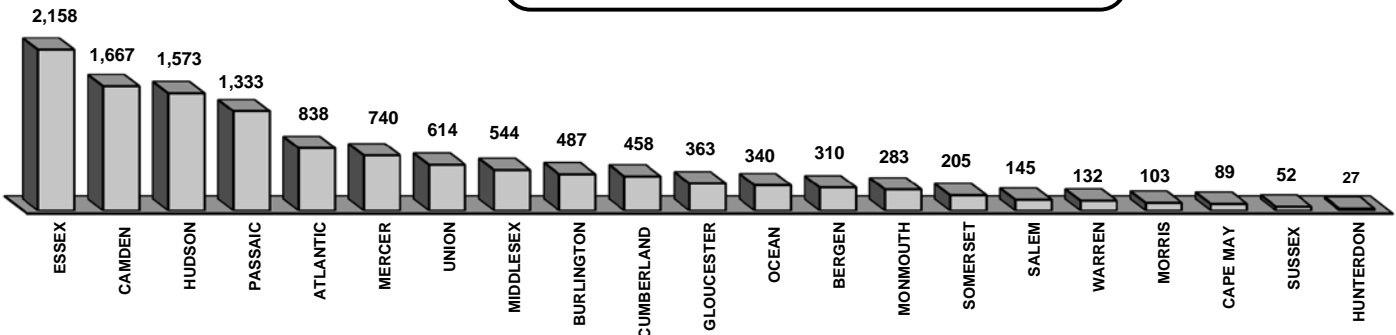

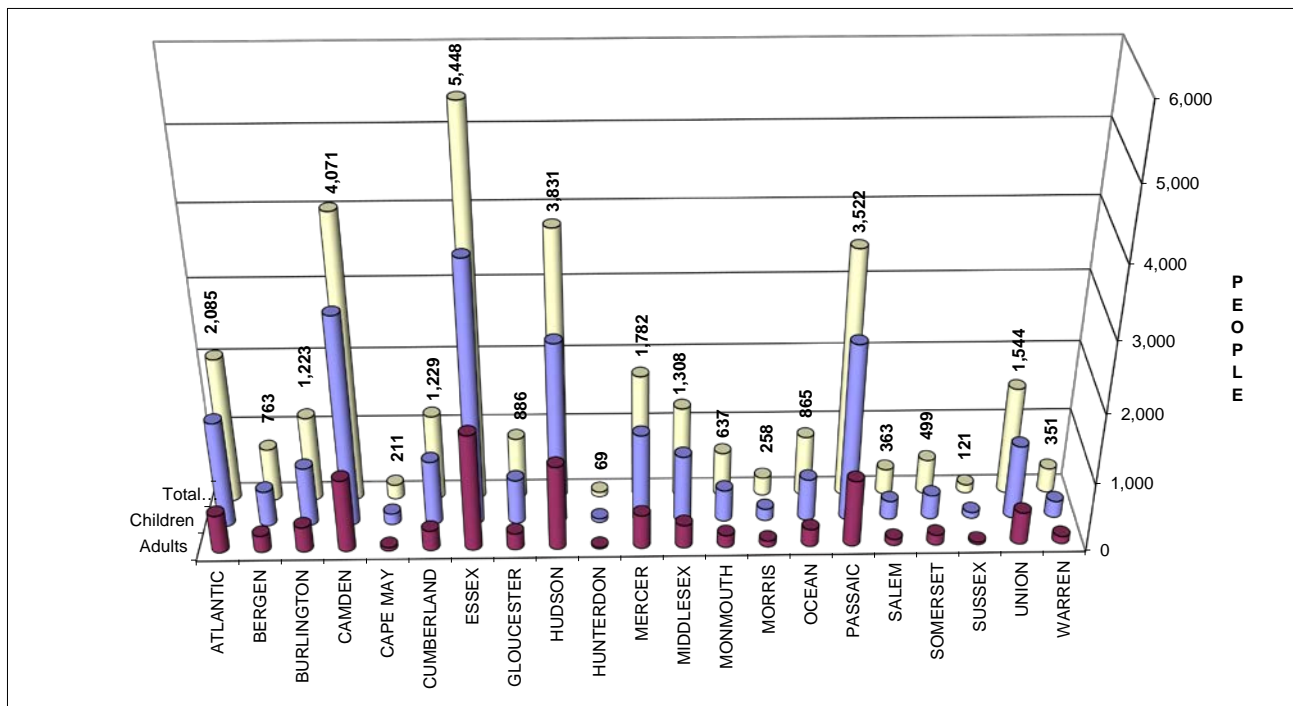

Ending With OCTOBER 2018

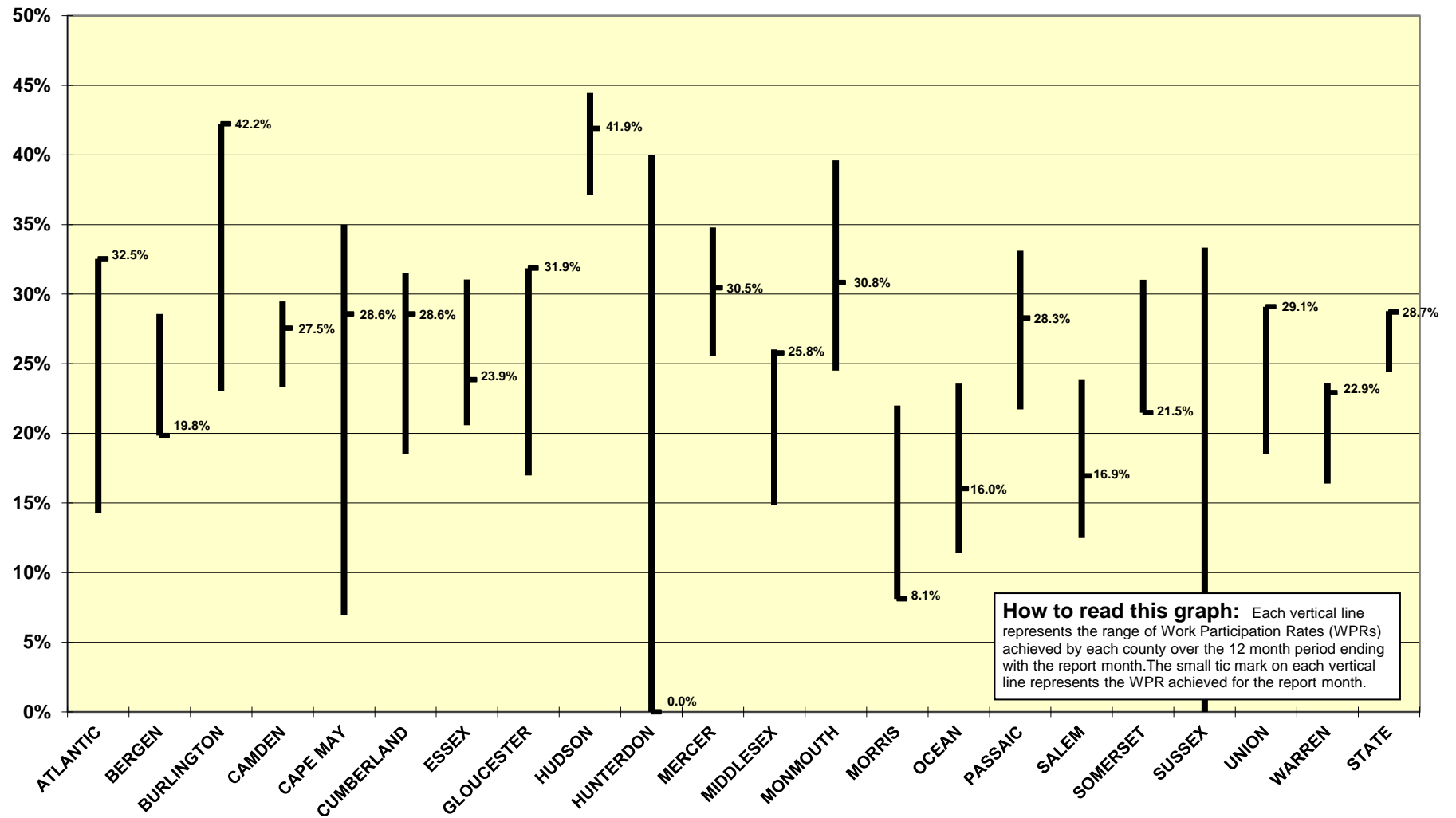
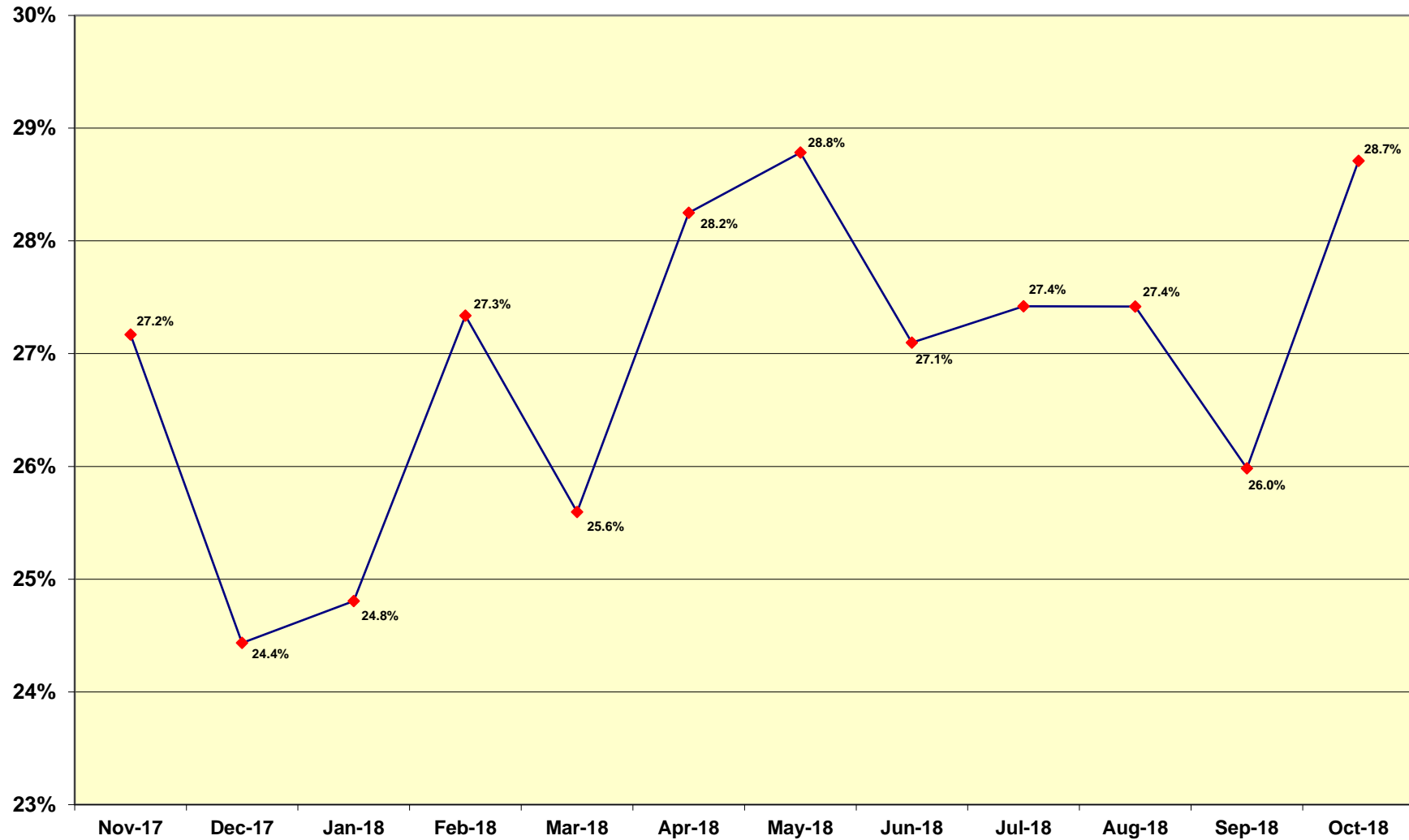

OCTOBER 2016 THROUGH OCTOBER 2018 (STATEWIDE)**



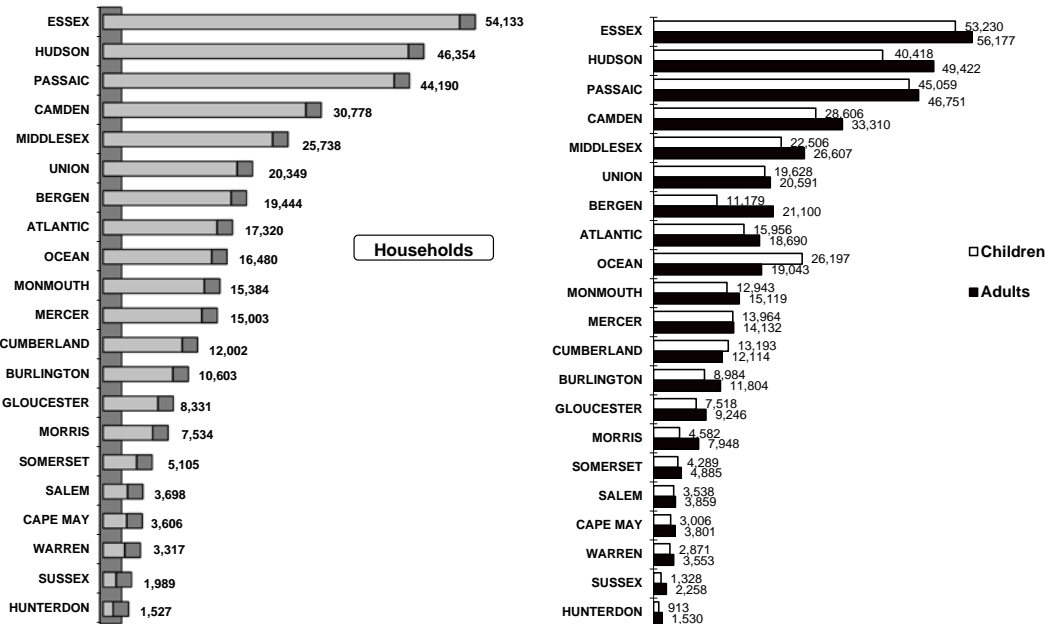

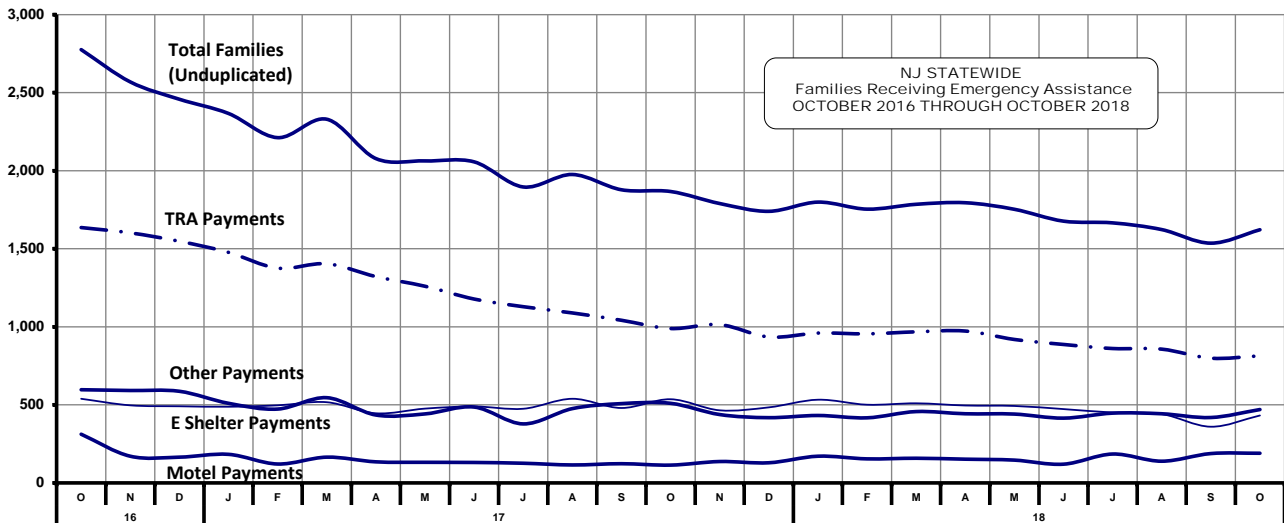

ACRONYMS

EMERGENCY ASSISTANCE (EA) - Payments to those eligible for WFNJ/TANF or WFNJ/GA, authorized during the 30 consecutive days immediately following the emergency (defined as a substantial loss of shelter, food, clothing, or household furnishings by fire, flood or other similar disaster) or if eligible individual or family is in an imminent or actual state of homelessness.

NJ SNAP - Formerly the Food Stamp Program, now known as **NJ SNAP** (NJ Supplemental Nutrition Assistance Program) authorized by Congress as a nutritional supplement program to provide low income households with more food of greater variety and better nutrition. Program eligibility is based on household income, resources, and expenses for medical, shelter, and dependent care. CWA staff refers certain recipients to the New Jersey Department of Labor for participation in the Food Stamp Employment and Training Program.

FAMIS: Family Assistance Management Information System

GAAS: General Assistance Automated System

NJKiDS: New Jersey Kids Deserve Support (Child Support Information Management System)

NJ MMIS SHARED DATA WAREHOUSE: The Shared Data Warehouse (SDW) is the repository for New Jersey's DFD and Medicaid data. Since 2003, OptumInsight has administered the SDW and provided access to the data through a reporting tool known as Business Objects.

OMEGA: Online Management of Economic Goal Achievement

SSI-EA: Supplemental Security Income-Emergency Assistance

WFNJ: Work First New Jersey - Fully implemented July 1, 1997, this is New Jersey's welfare reform program which responds to the requirements of the Federal Personal Responsibility and Work Opportunity Reconciliation Act (**PRWORA**) of 1996. PRWORA established Temporary Assistance for Needy Families (**TANF**) as the replacement for AFDC cash assistance. WFNJ includes two segments, **WFNJ/TANF** for families with children, and **WFNJ/GA** (General Assistance) for single adults and couples without dependent children. WFNJ emphasizes achieving self-sufficiency and limits lifetime receipt of financial assistance to a total of five years.
