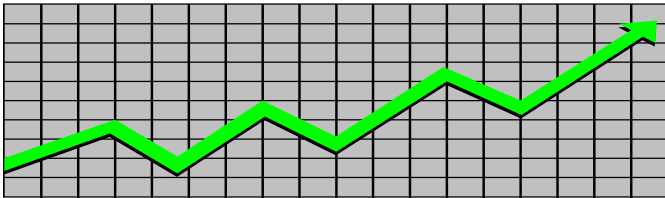

DIVISION OF FAMILY DEVELOPMENT CURRENT PROGRAM STATISTICS
SEPTEMBER 2020

Each month the Division of Family Development publishes its program statistics for: WFNJ/TANF, NJ SNAP, Emergency Assistance, General Assistance, and Child Support Services. When possible, information is provided separately for children and adults. Many tables also provide trend data with information broken down by county for readers to consider. This report is compiled and prepared by The Bureau of Research & Reporting.

WFNJ/TANF

- As of the end of September, the TANF caseload had increased by 789 cases, from 10,739 in September 2019 to 11,528 in September 2020, an increase of 7.3%.

- The counties with caseloads that increased the most since September 2019 were Somerset (32.7%), Hudson (42.4%) and Hunterdon (65.4%).

- The counties with caseloads that decreased the most since September 2019 were Cumberland (-8.5%), Salem (-9.0%) and Morris (-19.6%).

- Of the WFNJ/TANF cases, 3,603 or 31.3% were child-only in September 2020.

- The counties with the most child-only cases were Camden (577), Hudson (465) and Essex (427).

- Hudson (4,942), Essex (4,568), Camden (3,670), Passaic (3,043) and Atlantic (1,828) counties had the greatest number of persons receiving TANF in September 2020.

NJ SNAP (formerly FOOD STAMPS)

- In September 2020, there were 394,991 households receiving NJ SNAP benefits. The number of NJ SNAP households increased by 53,510 or 15.7%, since September 2019.

- There were 769,331 persons receiving NJ SNAP benefits as of September 2020, an increase of 95,365 or 14.1% since September 2019.

- The counties having the highest caseload increase since September 2019 are Somerset (21.2%), Warren (24.4%) and Hudson (31.0%).

EMERGENCY ASSISTANCE

- There were 1,624 TANF families receiving Emergency Assistance (EA) in September 2020, a decrease of 17 or -1.0% since September 2019.

- In September 2020, EA payments were made for 583 SSI recipients.

SEPTEMBER 2020**

- There were 2,182 GA cases with Emergency Assistance payments in September 2020, an increase of 23 or 1.1% since September 2019.
 - The counties that showed the highest percent increase in Emergency Assistance payments were Somerset (62.1%), Monmouth (66.7%) and Cape May (87.2%).
 - The counties that showed the highest percent decrease in Emergency Assistance payments were Cumberland (-52.6%), Sussex (-73.0%) and Salem (-80.0%).

GENERAL ASSISTANCE

- The total numbers of cases receiving GA has increased from 10,421 to 13,303 since September 2019, an increase of 27.7%.
- There were 8,176 Employable GA and 5,127 Unemployable GA cases in September 2020.
- The counties that showed a percent increase for GA cases were Somerset (47.3%), Hudson (68.4%) and Salem (74.5%) since September 2019.
- The counties that showed the highest percent decrease for GA cases since September 2019 were Morris (-1.0%) and Hunterdon (-20.9%).
- In September 2020, GA cases showed a -0.6% decrease since August 2020.

CHILD SUPPORT SERVICES (Quarterly Report)

- The total collection for the Child Support Services Program was about \$302 million from July 2020 to September 2020, a decrease of -0.7 percent over the same period for FFY 2019.
- Total distributions decreased -1.2% from September 2019.

WORK FIRST NEW JERSEY (WFNJ)

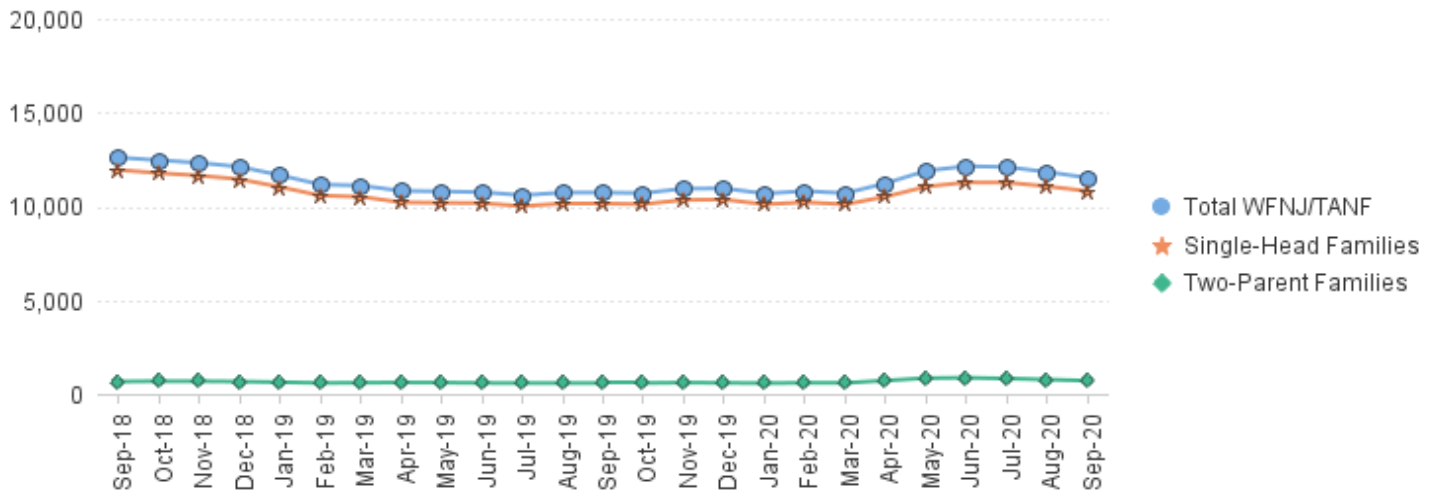
- During the report month of September 2020, there were 340 families in which at least one member was employed and an additional 109 families whose WFNJ assistance cases were closed due to employment - related earnings.
- The four counties with the greatest number of employed active WFNJ recipients were: Essex (65), Hudson (59), Atlantic (33) and Camden (33).
- There were 780 former TANF cases receiving post-TANF support in the form of child care assistance.

SEPTEMBER 2018 THROUGH SEPTEMBER 2020



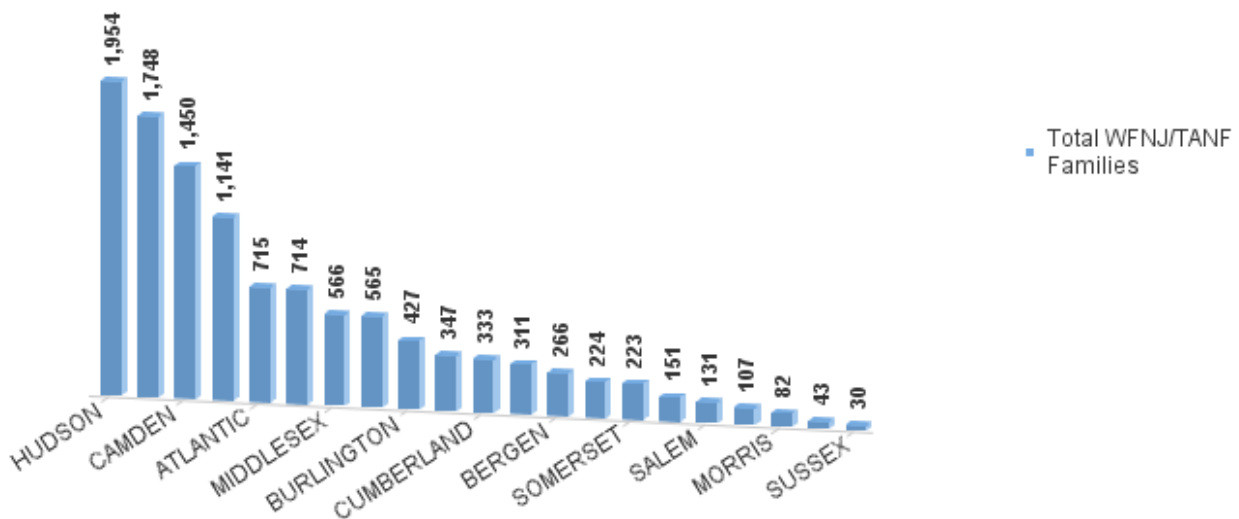

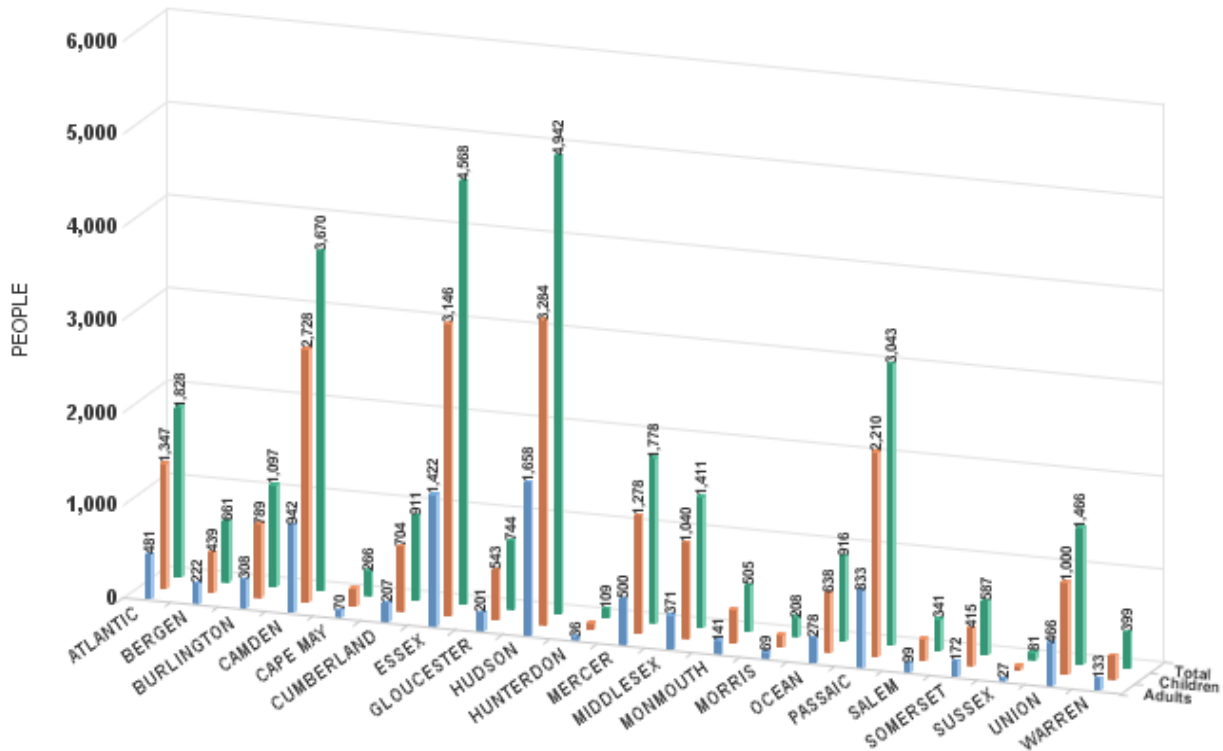

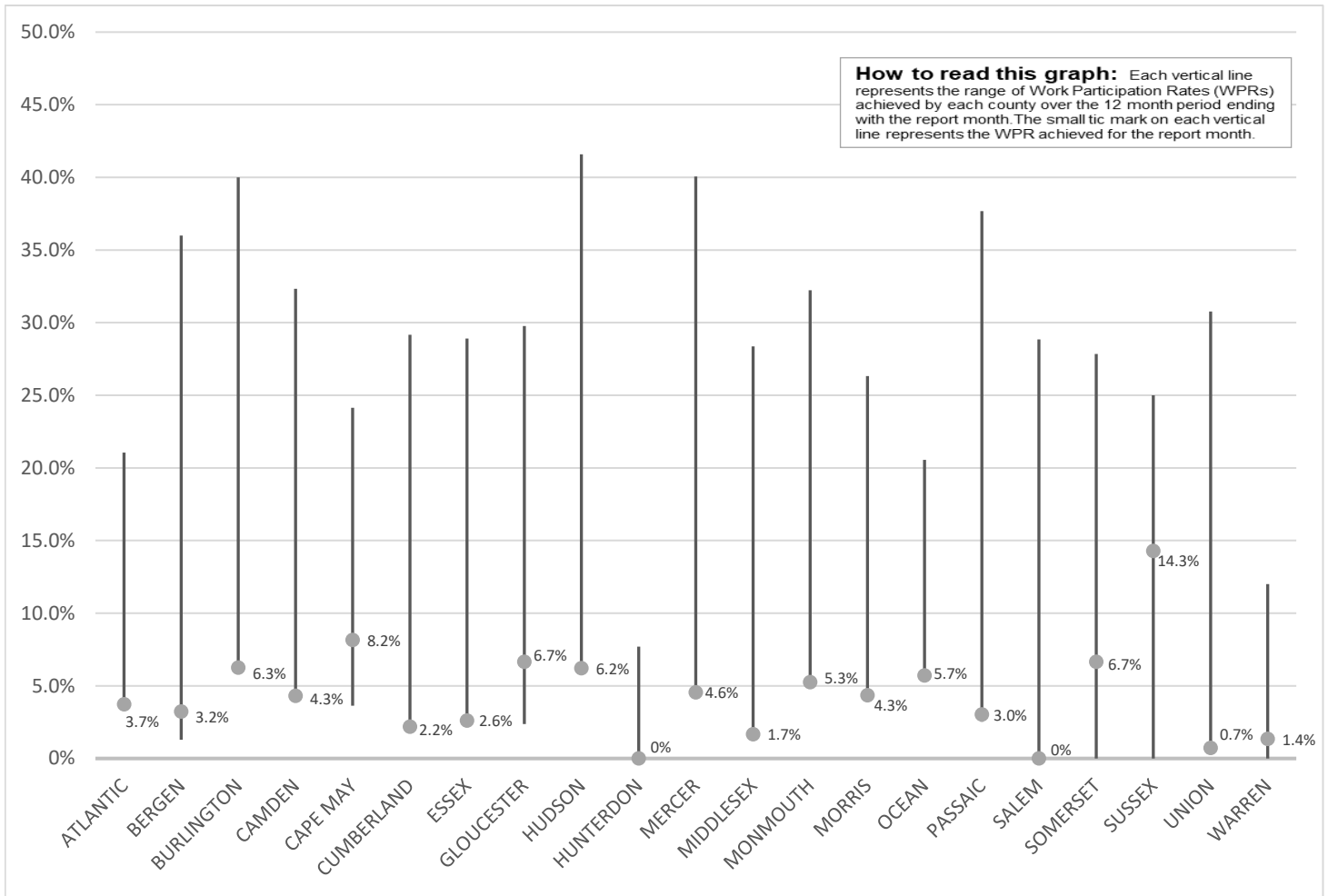

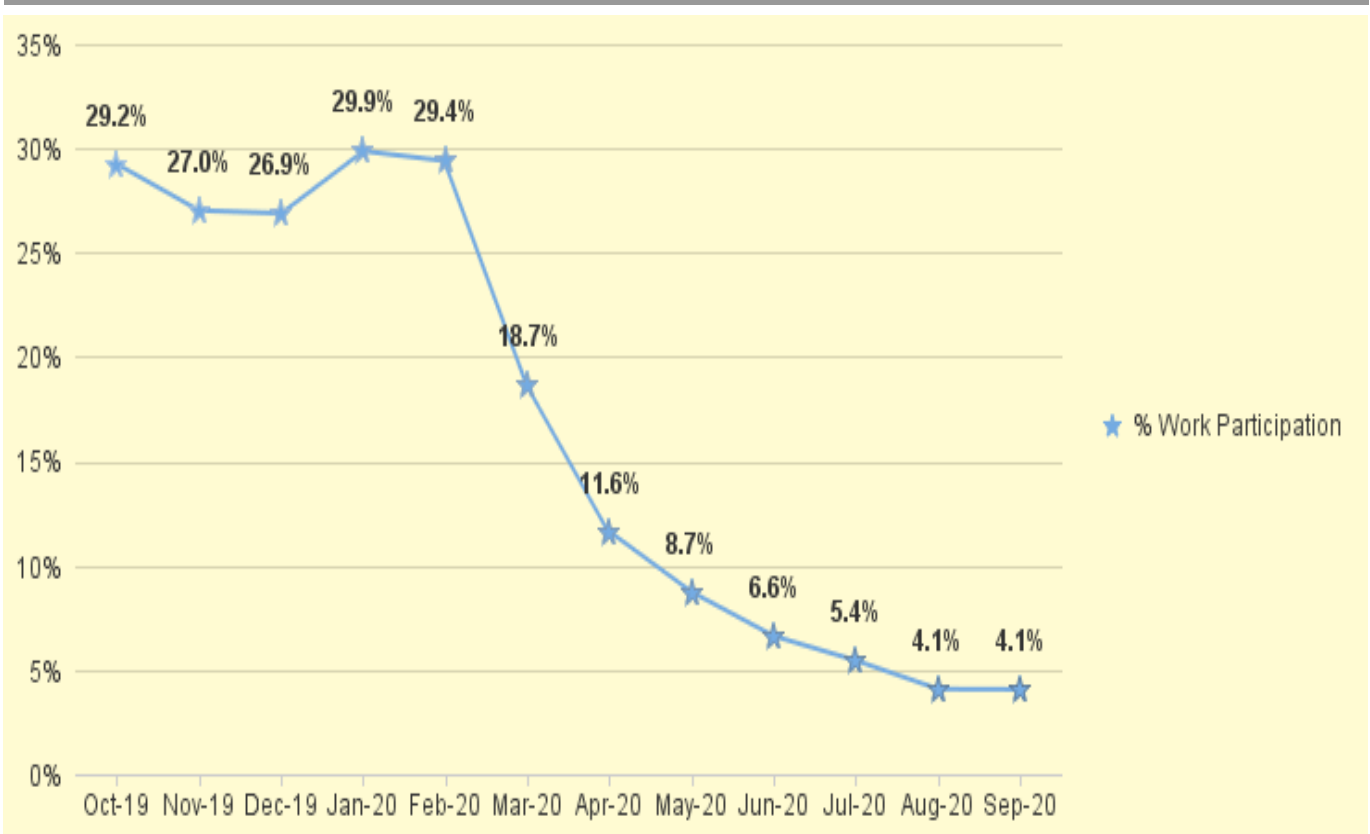
Work Participation Rates Achieved Over 12 Month Period

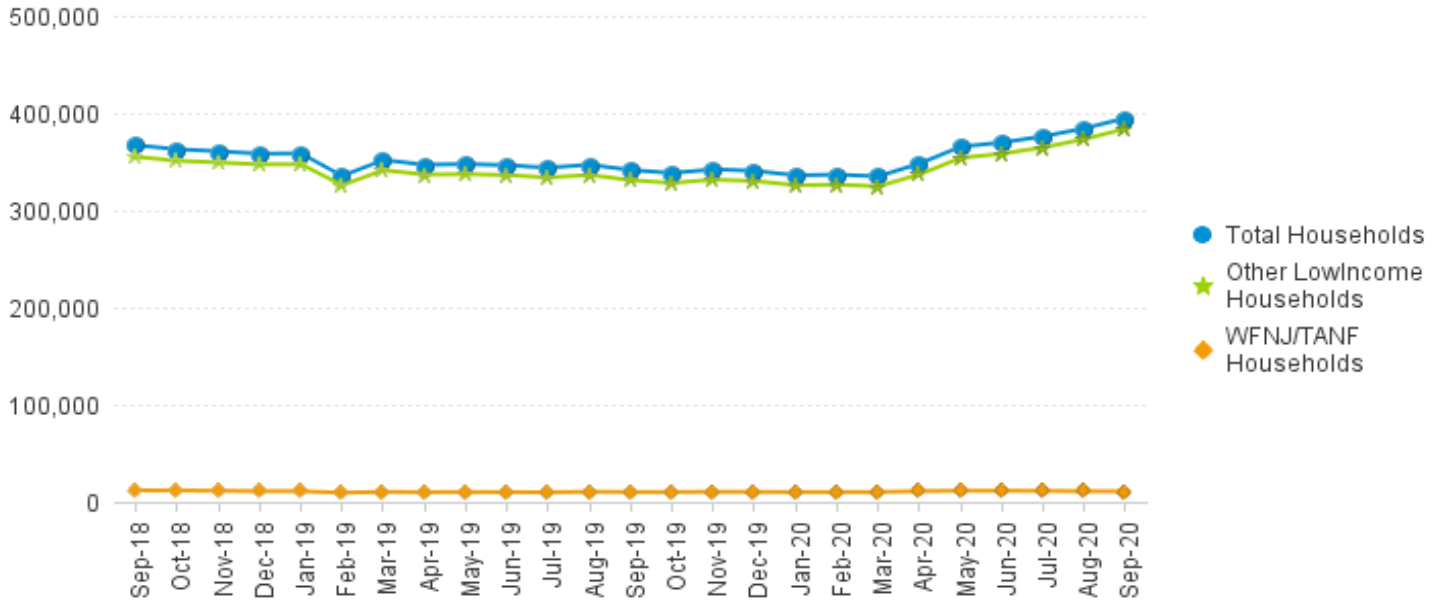

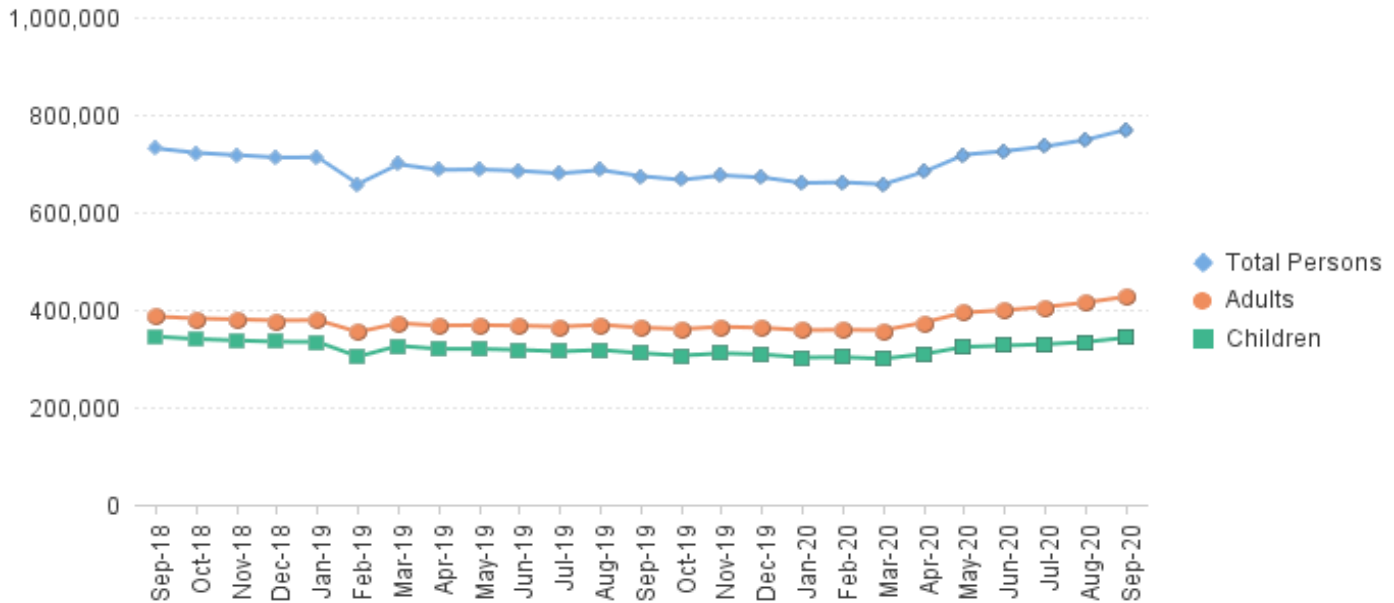

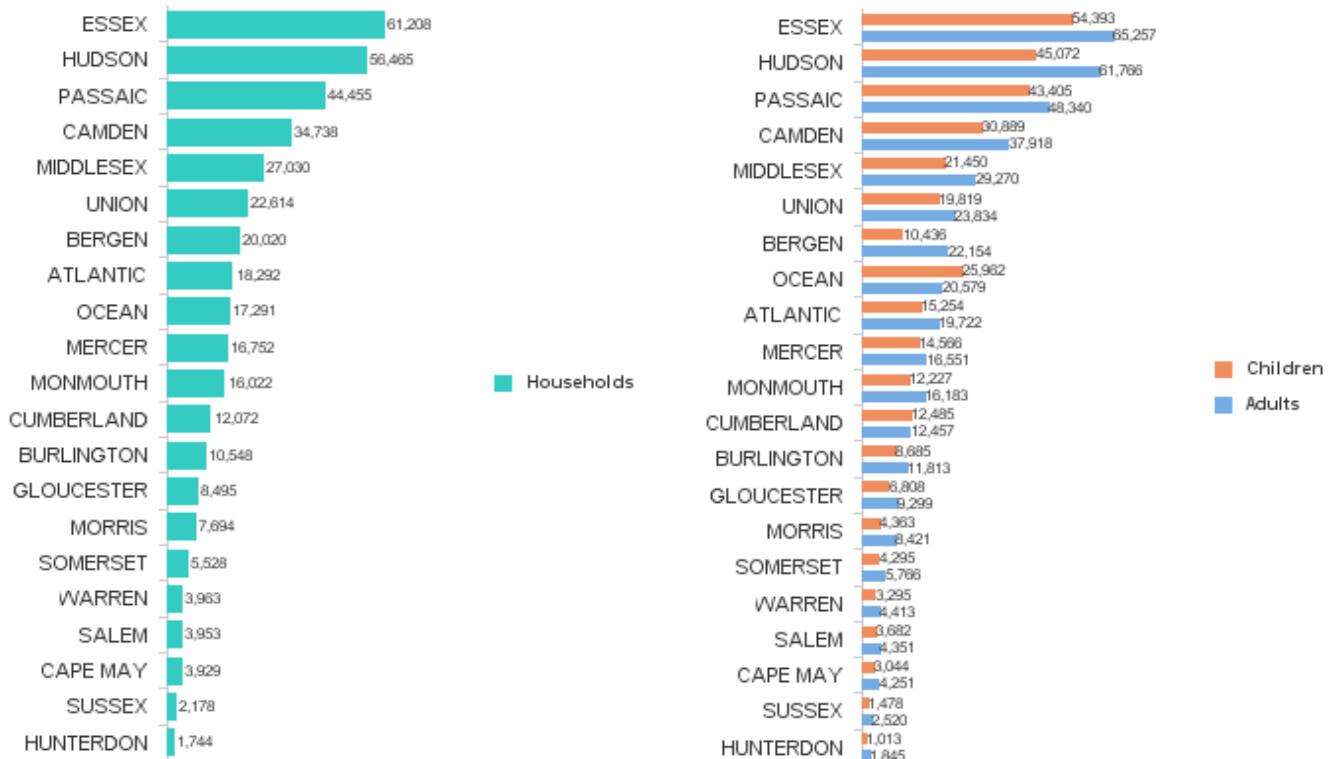

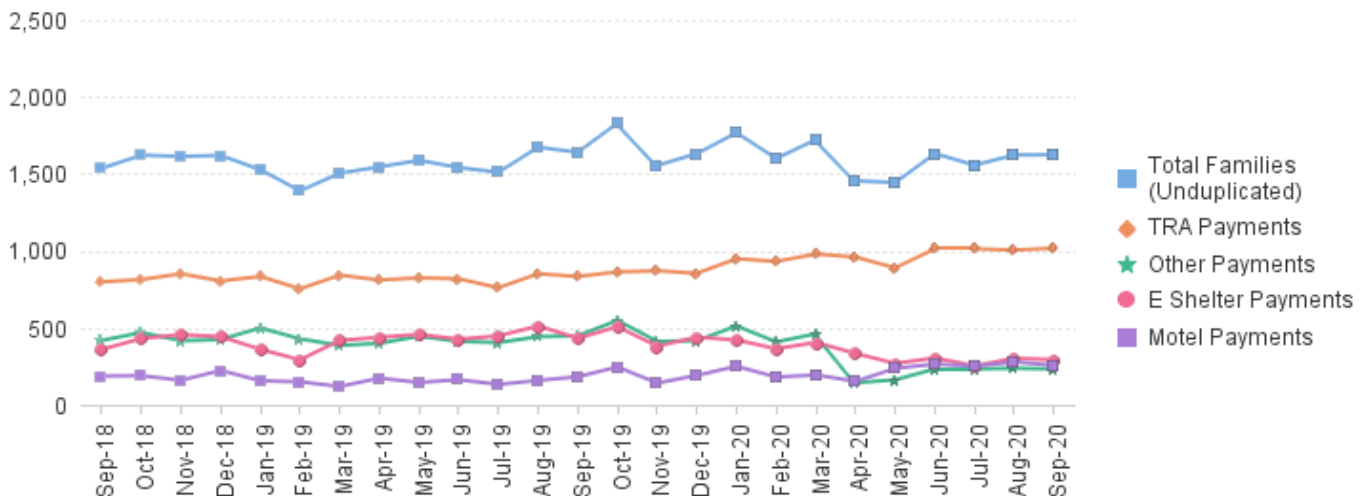

ACRONYMS

EMERGENCY ASSISTANCE (EA) - Payments to those eligible for WFNJ/TANF or WFNJ/GA, authorized during the 30 consecutive days immediately following the emergency (defined as a substantial loss of shelter, food, clothing, or household furnishings by fire, flood or other similar disaster) or if eligible individual or family is in an imminent or actual state of homelessness.

NJ SNAP - Formerly the Food Stamp Program, now known as **NJ SNAP** (NJ Supplemental Nutrition Assistance Program) authorized by Congress as a nutritional supplement program to provide low income households with more food of greater variety and better nutrition. Program eligibility is based on household income, resources, and expenses for medical, shelter, and dependent care. CWA staff refers certain recipients to the New Jersey Department of Labor for participation in the Food Stamp Employment and Training Program.

FAMIS: Family Assistance Management Information System

GAAS: General Assistance Automated System

NJKIDS: New Jersey Kids Deserve Support (Child Support Information Management System)

NJ MMIS SHARED DATA WAREHOUSE: The Shared Data Warehouse (SDW) is the repository for New Jersey's DFD and Medicaid data. Since 2003, OptumInsight has administered the SDW and provided access to the data through a reporting tool known as Business Objects.

OMEGA: Online Management of Economic Goal Achievement

SSI-EA: Supplemental Security Income-Emergency Assistance

WFNJ: Work First New Jersey - Fully implemented July 1, 1997, this is New Jersey's welfare reform program which responds to the requirements of the Federal Personal Responsibility and Work Opportunity Reconciliation Act (**PRWORA**) of 1996. PRWORA established Temporary Assistance for Needy Families (**TANF**) as the replacement for AFDC cash assistance. WFNJ includes two segments, **WFNJ/TANF** for families with children, and **WFNJ/GA** (General Assistance) for single adults and couples without dependent children. WFNJ emphasizes achieving self-sufficiency and limits lifetime receipt of financial assistance to a total of five years.
