### I. Welcome/Administrative Issues/Announcements

- A. Minutes from last meeting (1/13/16) approved with addition of approval of December minutes.

# II. **NJ DCSOC : Juvenile Justice** – Kim Doyle Maloney & Michael Higginbotham A. Power Point presentation – will be sent out to council.

- B. Question Marie Where might there be bottlenecks? At what milestones? What is the average length of stay? Answer Kim Doyle Maloney Depends, there are only 2 youths awaiting at this time in the entire state. May take 70 days. There is a system analysis to measure, should be complete. JJC should have it. In out of home treatment, average is 11 months, trying to get that to 9 months.
- C. Question Winifred Are all police stations aware of services?

Answer – Kim – We can't train all police, but a lot of prosecutors have done the training. Camden and Ocean counties but I can't say every county.

Q – Winifred – Can they request for you to come out & present? A- Kim – We would have our local CMO's do the presentations but we have been really networking with the local police departments so they should know about how to access our services.

Q- Winifred – Can a parent request?

A – Kim – Absolutely.

A – Mike – That's Perform Care, a parent can call and see what's available. It's available 24 hours a day.

Q – John – If someone intervenes, are there delays in getting those treatments? A – Kim – In terms of SA, there are many openings, severely underutilized, no capacity issue on our end and we can't figure out why.

Q – Dan – Are you tied into Rutgers.

A - Kim - No, SA up to 18.

Q- Ellen – Any counties still sending out of state for treatment?

A - Kim – No.

Q – Mary Abrams – on the vacancies on the SA services, isn't that different for the different age groups, for the older and the younger had the vacancies? A- Kim – We don't do older or younger, it's just up to 18.

Q- Michael Litterer – Parents may feel there are greater leniencies with MH rather than SA, may be why there's many vacancies for SA.

A- Kim – They can access our services directly, not necessary to go through judge.

Q – Geri – Do you do presentations for particular groups? A – Mike – Reach out to local CMO's, they're the ones that would handle that. But if there's a statewide presentation that's needed, absolutely.

Q – Connie – The underutilization, is that equally? A - Kim - Yes.
