  - A. Mental Health Block Grant (Donna Migliorino).
    - 1. At the July 10<sup>th</sup> meeting the following sections were reviewed: Planning Step1: Assess the strengths and organizational capacity of the service system to address specific populations, Planning Step 2: Identify the unmet needs and critical gaps within the current system, and Selection sections for Planning Step 3.
    - 2. Planning Step 3, Environmental Factors, Sections About the Planning Council (Mark Kruszczynski),
      - a. "21. State Planning/Advisory Council and Input on the Mental Health /
        Substance Abuse Block Grant Application "– Required by MHBC. Reviewed.

        - i. Advisory Council Composition by Member Type:
          - Total Individuals in Recovery, Family Members & Others = 61.5%.
          - Total State Employees & Providers = 38.5
        - ii. "Is the membership representative of the service area population?" No.
          - DMHAS realizes that the composition of the Planning Council does not yet adequately reflect the demographic variation of the

- state of New Jersey. It makes efforts to correct this through the recruitment and membership selection processes of the BHPC.
- The BHPC makes efforts to increase the diversity among its members.

- **III. Substance Abuse Block Grant** (Suzanne Borys, DMHAS). [At the July 10, 2019 meeting of the BHPC this material was reviewed].
  - A. Priority Areas and Performance Indicators [not covered on 7/10/19]
    - 1. A 1% increased use of medication assisted treatment (MAT) for substance use disorders.
      - a. Creation of New Jersey "Centers of Excellence" at Rutgers University and Rowan College for MATI innovation.
      - b. Medicaid OBAT program.
    - 2. Reduced tobacco use (including e-cigarettes, vaping, etc.) from 4.64% to a target of 4%.

  - A. Performance Indicators
    - 1. Aligning Early Childhood & Medicaid Initiatives
      - a. Screening, ages 0-3
      - b. Identify best practices in pediatric medical homes; expanded care coordination; connecting newborns and mothers with nutrition, childcare, and primary health services.
    - 2. Pilot: In-Home Recovery Program (RFP); Nicholas Foundation/Yale Child Study Center
      - a. Ages 0-3
      - b. One award, two implementation sites
      - c. Ocean County, NJ, 36 families
    - 3. Increase in Integrated Care: Increasing behavioral health homes (bhhs), and providing services in innovated ways.
- **V. Presentation of the Family Support Organization** (J. Barugel) [Originally scheduled for July 10, 2019]. [PowerPoint presentation emailed to Council on 8/15/19]. In addition to the content presented in the actual presentation document the following commentary was provided:
  - A. Personal background
  - B. Brief history of FSO & CMO. Unification of FSO with CMO.
  - C. Importance of the 'aging out' process (i.e., whereby children receiving services from the children's system of care begin services with the adult system of care)
  - D. About 33% of families enrolled with the Monmouth County FSO have involvement with the NJ Division of Child Protection and Permanency (DCP&P).
  - E. Each county's FSO has slightly different operations and approaches.
  - F. FSO staff are recruited among families with lived experience of having children/loved ones with serious emotional disturbance (SED). It is difficult to recruit such families to work for the FSOs, due to the added commitments and obligations of families with children who have SED.
  - G. Review of anecdotal positive comments of families served by the FSO.

### VI. State Partners Involvement

A. NJ Department of Education (DoE), (Damian Petino)

- 1. New state law that requires the NJ DoE to add mental health to middle and high school health curriculum.
- 2. Recent conference on School Equity was organized by DoE on 7/31/2019. This was a successful and well-attended event.
- 3. DoE will launch a pilot study of five districts to have alternate (later) daily school start/school end times. Issues such as transportation, extra-curricular activities and academic performance will be examined.
- 4. DoE is looking at the University of Maryland's National Center for School Mental Health (NCSMH) <a href="https://csmh.umaryland.edu/">https://csmh.umaryland.edu/</a>.
- 5. NCSMHA offers the The School Health Assessment and Performance Evaluation (SHAPE) System- which is a free, web-based portal designed specifically for school and district teams to assess and enhance their school mental health services. - 6. DoE's use of the "Every Mind Matters" campaign
- 7. Comment: Concern of schools prematurely sending children to screening centers when "acting out' behaviors are exhibited.
- B. NJ Department of Health (as reported by P. Lubitz): The NJ Public Defender's Office and the NJ Department of Health have agreed upon a mediation process to examine/resolve potential issues at the Greystone Park State Psychiatric Hospital

#### A. Block Grant

- 1. Met on 7/10/19, and 8/15/19. See minutes from the General Meeting on 8/15/19 (see above) and 7/10/19 for more information on the 2020-2021 CMHBG and SABG Applications. The federal deadline is 9/1/19. However other internal state deadlines are much earlier
  - a. The full membership of the Council unanimously agreed to approve the current draft of New Jersey's 2020-2021 CMHBG and SABG Applications.
  - b. As sections are vetted, revised and approved by DMHAS Executive Management the information will be loaded into the WebBGas federal website (see above for login information and credentials).

- 1. Still working on draft letter from the Council to Assistant Commissioner Mielke to Advocate for improved, consistent knowledge base of all front line staff at behavioral health agencies contracted by DMHAS.
