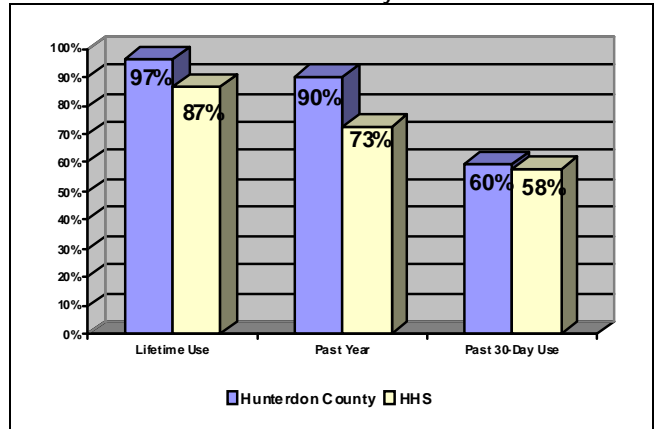


Data were collected on 411 clients in 2009 who went through the Hunterdon County Intoxicated Driver Resource Center program or were monitored by the Hunterdon County IDRC. 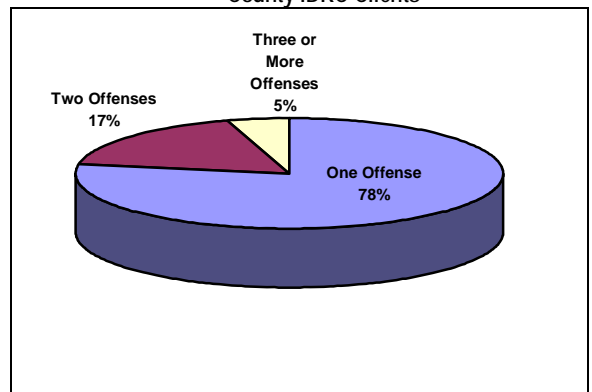

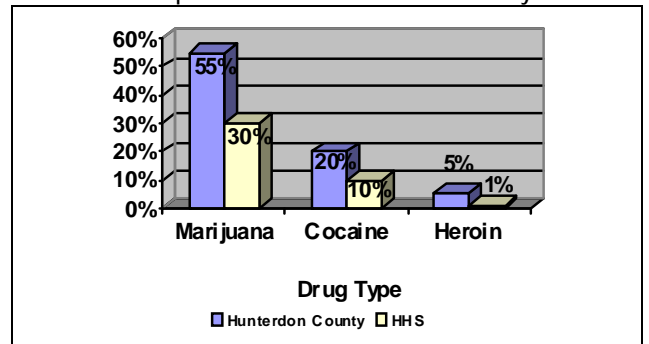
Alcohol Use by Hunterdon County IDRC Clients Compared with 2003 NJ Household Survey



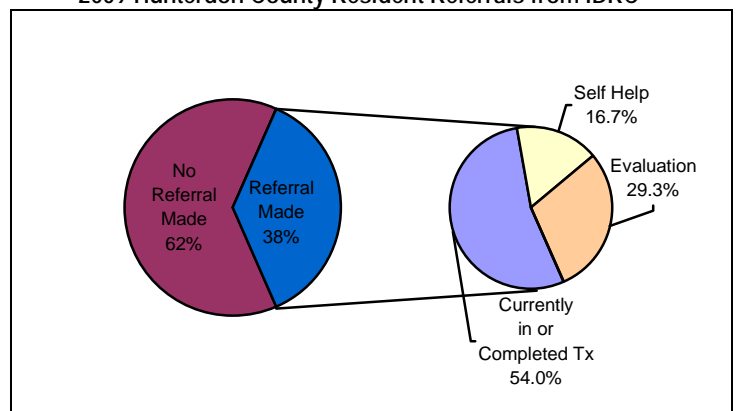
Number of Alcohol-Related Offenses on DMV Records of Hunterdon County IDRC Clients

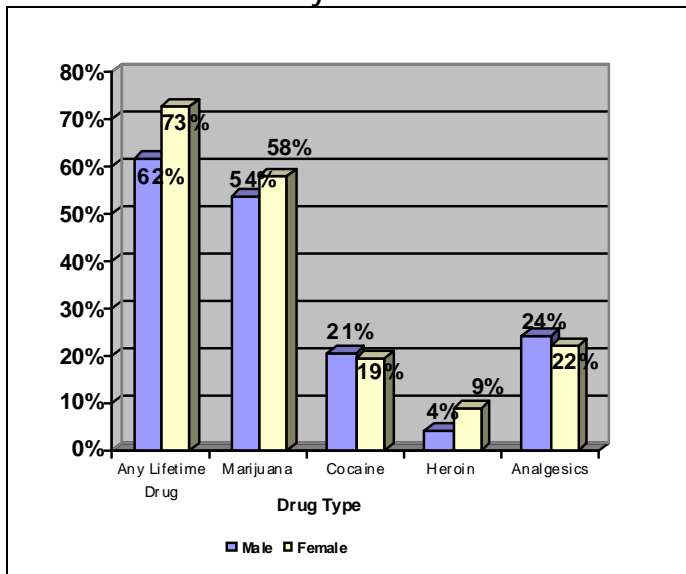
