DEFINITION	Under the supervision of a Quality Assurance Coordinator or other supervisory official in the Division of Mental Health and Addiction Services, serves as the Division's liaison to all agencies within assigned counties to timely identify and follow up on incidents, and SUD complaints involving consumers receiving community-based mental health and addiction services treatment. Assists the agency in identifying the cause or contributing factors leading up to incidents. Reviews prevention plans and plans of corrections to reduce the likelihood of the incidents occurring again. Assess the quality of the incidents and follow up reports, while reaching out to agencies for additional information as needed. Conducts training as required with community agencies and providers. Does other related duties as necessary.

EDUCATION	A License as a Registered Nurse in the State of New Jersey				
EXPERIENCE	Four (4) years of experience as a Registered Nurse, one (1) year of which is specialized experience including the monitoring and/or evaluation of clinical or human services records and programs in a mental health, geriatric, health care setting, or human services agency.				
NOTE	<ul style="list-style-type: none"> ➤ A Bachelor's degree, and three (3) years of specialized experience in the field of quality assurance in a mental health, geriatric, health care setting, or human services agency which includes monitoring and/or evaluation of clinical or human services records and programs which may include allegations of abuse, neglect, exploitation, or incidents of client abuse or safety and well-being, may be substituted for the above license and experience requirements. ➤ A Master's degree in Public Health or a health care related field may be substituted for one (1) year of indicated experience. 				
NOTE FOR FOREIGN DEGREES	Degrees and/or transcripts issued by a college or university outside of the United States must be evaluated by a reputable evaluation service at your expense. The evaluation must be included with your submission. Failure to submit the required evaluation may result in an ineligibility determination.				
LICENSE	Appointees will be required to possess a driver's license valid in New Jersey only if the operation of a vehicle, rather than employee mobility, is necessary to perform the essential duties of the position.				
IMPORTANT NOTICE					
RESIDENCY	Effective 9/1/11, NJ PL 70 (NJ First Act), requires all State employees to reside in New Jersey, unless exempted under the law, or current employees who live out-of-state and do not have a break-in service of more than 7 calendar days, as they are "grandfathered." New employees or current employees who were not grandfathered and who live out-of-state have one year after the date of employment to relocate their residence to New Jersey or request an exemption. Current employees who reside in NJ must retain NJ residency, unless he/she obtains an exemption. Employees who fail to meet the residency requirements or obtain an exemption will be removed from employment.				
NOTE	Applicable special re-employment list established as a result of a layoff will be used before any promotions are made.				
DRUG SCREENING	If you are a candidate for a position that involves direct client care in one of the Department of Human Services' hospitals or developmental centers, you may be subject to pre and/or post-employment drug testing/ screening. The cost of any pre-employment testing will be at your expense.
