

# NJ NATIONAL GUARD APPLICATION

1. APPLICANT MUST BE AN ACTIVE MEMBER OF THE NJ NATIONAL GUARD
2. APPLICANT MUST HAVE COMPLETED BASIC TRAINING
3. **ATTACHED LES SHOWING ACTIVE TRAINING WITHIN 90 DAYS OF APPLICATION**
4. ATTACHED ORIGINAL PREVIOUS LICENSE OR NJ SAFETY COURSE CARD
5. DIVISION OF FISH AND WILDLIFE CONSERVATION IDENTIFICATION NUMBER (CID)
6. CHILD SUPPORT CERTIFICATION MUST BE RENEWED PRIOR TO ISSUE OF LICENSE

## FISHING

REQUIRED BY ANY PERSON FISHING IN NEW JERSEY \*\*PREVIOUS LICENSE NOT REQUIRED\*\*

## TROUT STAMP

REQUIRED IN ADDITION TO FISHING LICENSE FOR TROUT FISHING

## CRAB DREDGE, NON-COMM.

THIS LICENSE IS VALID FOR USE OF TWO DREDGES, MECHANICAL HAULERS ARE PROHIBITED. MAXIMUM HARVEST IS ONE BUSHEL PER DAY. CRABS CANNOT BE SOLD OR USED FOR BARTER. REFER TO NJDFW MARINE DIGEST FOR MORE INFORMATION.

## CRAB POT, NON-COMM.

THIS LICENSE IS VALID FOR USE OF TWO CRAB POTS OR TWO TROUT LINES. MAXIMUM HARVEST IS ONE BUSHEL PER DAY. CRABS CANNOT BE SOLD OR USED FOR BARTER. REFER TO NJDFW MARINE DIGEST FOR MORE INFORMATION.

## SHELLFISH RECREATIONAL

MAXIMUM HARVEST 150 CLAMS/DAY FOR PERSONAL CONSUMPTION ONLY (SALE PROHIBITED). HARVEST PROHIBITED FROM: CONDEMNED WATER; LEASED GROUNDS (EXCEPT BY LESSEE); BEFORE SUNRISE, AFTER SUNSET, AND ON SUNDAY. MINIMUM HARD CLAM SIZE 1.5 INCHES. VALID THROUGH JUNE 1 – SEPTEMBER 30.

## RIFLE PERMIT

A PREVIOUS NEW JERSEY RIFLE PERMIT OR A NEW JERSEY RIFLE HUNTER SAFETY COURSE CARD MUST BE SUBMITTED TO RECEIVE A RIFLE PERMIT. A FIREARM LICENSE, FIREARM PURCHASE CARDS OR AUTHORIZATION TO CARRY WEAPONS CARDS ARE NOT ACCEPTED FOR ISSUE OF A RIFLE PERMIT. A RIFLE PERMIT IS VALID FOR A ONE YEAR PERIOD.

## ALL AROUND SPORTSMAN

**THIS IS A COMBINATION FIREARM, BOW AND ARROW AND FISHING LICENSE.** A PREVIOUS ORIGINAL NEW JERSEY SPORTSMAN LICENSE, OR BOTH AN ORIGINAL NEW JERSEY FIREARM AND AN ORIGINAL NEW JERSEY BOW AND ARROW LICENSE, OR AN ORIGINAL RESIDENT FIREARM AND ORIGINAL RESIDENT BOW AND ARROW LICENSE FROM ANY STATE, OR BOTH AN ORIGINAL NEW JERSEY FIREARM AND BOW AND ARROW HUNTER EDUCATION SAFETY COURSE CARD MUST BE SUBMITTED TO RECEIVE THIS LICENSE

## FIREARM

PERSON APPLYING FOR A FIREARM LICENSE MUST SUBMIT AN ORIGINAL PREVIOUS NEW JERSEY FIREARM LICENSE, OR AN ORIGINAL RESIDENT FIREARM LICENSE FROM ANY OTHER STATE, OR AN ORIGINAL NEW JERSEY FIREARM EDUCATION SAFETY COURSE CARD

## BOW AND ARROW

PERSON APPLYING FOR A BOW AND ARROW LICENSE MUST SUBMIT AN ORIGINAL PREVIOUS NEW JERSEY BOW AND ARROW LICENSE, OR AN ORIGINAL RESIDENT BOW AND ARROW LICENSE FROM ANY OTHER STATE, OR AN ORIGINAL NEW JERSEY BOW AND ARROW HUNTER EDUCATION SAFETY COURSE CARD

## TRAPPER

PERSON APPLYING FOR A TRAPPER LICENSE MUST SUBMIT AN ORIGINAL PREVIOUS NEW JERSEY TRAPPER LICENSE, OR AN ORIGINAL RESIDENT TRAPPER LICENSE FROM ANY OTHER STATE, OR A ORIGINAL NEW JERSEY TRAPPER EDUCATION SAFETY COURSE CARD

## PHEASANT AND QUAIL STAMP

## HIP CERTIFICATION AND RESIDENT WATERFOWL

ALL HUNTERS MUST OBTAIN A HIP CERTIFICATION BEFORE HUNTING DUCKS, GEESE, BRANT, COOT, WOODCOCK, RAILS, SNIPE, OR GALLINULES. A NJ WATERFOWL STAMP CERTIFICATION AND MIGRATORY BIRD HUNTING AND CONSERVATION STAMP (FEDERAL DUCK STAMP) ARE REQUIRED FOR ALL WATER-FOWL HUNTERS 16 YEARS OF AGE AND OLDER AND MUST BE SIGNED IN INK ACROSS THE FACE OF THE STAMP. NEW JERSEY STAMP CERTIFICATION (THE STAMP ITSELF NO LONGER EXISTS)
