The Next-of-Kin Registry, established by statute N.J.S.A. 39:4-134.2, also known as Sara's Law, is a statewide, web-based system that allows individuals aged 14 and older to voluntarily submit and maintain emergency contact information through the New Jersey Motor Vehicle Commission (NJMVC). This non-public information will be used by law enforcement officials to locate designated emergency contacts if an individual is involved in a motor vehicle accident that renders him or her unable to communicate.

- · This form is designed to register for the first time or to update your existing information with the Next-of-Kin Registry.
- You must have a non-driver identification (ID) card or driver license (DL) to register.
