Dear Juvenile Justice Colleague:

I am pleased to present the 2010 juvenile detention statistics prepared by the Compliance Monitoring Unit. Since 2008, six counties have closed their juvenile detention centers and are now sending juveniles requiring secure detention to neighboring county detention facilities. The following is a summary of the consolidations: Warren County closed its detention center on December 31, 2008, and now sends juveniles needing secure detention to the Morris County juvenile detention center; Passaic County closed its detention center on April 3, 2009, and now sends juveniles needing secure detention to the Essex County juvenile detention center; Gloucester County closed its detention center on June 3, 2009, and has sent juveniles needing secure detention to the Camden, Middlesex, Cumberland and Burlington County juvenile detention centers; Sussex County closed its detention center on December 15, 2009, and now sends juveniles needing secure detention to the Morris County juvenile detention center; Monmouth County closed its detention center on July 1, 2010, and now sends juveniles needing secure detention to the Middlesex County juvenile detention center; and, Mercer County closed its detention center on June 24, 2011, and now sends juveniles needing secure detention to the Middlesex County juvenile detention center.

Additionally, the Commission placed a "soft cap" in January 2006 on the Bergen County Juvenile Detention Center. Prior to reaching the "soft cap," Bergen County has transferred juveniles requiring secure detention to Morris and Union Counties. For operational purposes in 2010, Bergen juveniles were first admitted to the Bergen County detention facility and counted as admissions, then transferred to the Morris or Union County detention facilities where they were again counted as admissions. Also, Union County entered into an agreement with the U.S. Department of Health and Human Services in July 2009 to house a maximum of 15 federally detained juveniles in the County's juvenile detention center.

Due to these transfer/alternative housing arrangements, the 2010 detention statistics are presented in two ways. The first set of statistical tables, beginning with Table I, document the actual number of admissions and related child care days for each detention facility. A set of adjusted tables identified by an "A", beginning with Table I-A (Adjusted), are being provided, where applicable, to depict the figures for the counties noted above, had there been no transfer/alternative housing arrangements.




The Statistics include information on admissions, childcare days, average daily population, and average length of stay. Two-year comparisons are provided as well as five-year statewide comparisons, where appropriate. Also, statistics are provided for county juvenile detention facilities that have juvenile detention commitment programs.

Please note that Cape May, Hunterdon, Salem and Somerset counties also do not operate juvenile detention centers. These counties send juveniles needing secure custody to neighboring county juvenile detention facilities. In the case of Somerset County, all juveniles needing secure detention are transferred to the Middlesex County Juvenile Detention Center. For statistical purposes, Somerset County's admissions and childcare days are listed separately from the Middlesex County figures in adjusted Tables I-A through IX-A.

In closing, I hope the statistics are helpful to you and thank you for your interest in this matter.

SUBJECT: Statistics on Juveniles in Detention Facilities - 2010

Attached are the statistics on juveniles placed in detention facilities in New Jersey during 2010, prepared by the Commission's Compliance Monitoring Unit. The data was collected through the completion of forms (Monthly Population Report for Juvenile Detention Facilities) received from each county facility and verified, if necessary, by phone.

The 2010 detention statistics are presented in two ways due to the following transfer/alternate housing arrangements engaged in by various counties. The Commission placed a "soft cap" of 14 on the Bergen County Juvenile Detention Center in January 2006. The County has made arrangements to house, as necessary, juveniles needing secure detention in Morris and Union Counties. Also, Union County entered into an agreement with the U.S. Department of Health and Human Services in July 2009 to house a maximum 15 federally detained juveniles in the County's juvenile detention center. In addition, all juveniles requiring secure detention in Somerset County are transferred to the Middlesex County Juvenile Detention Center.

Additional transfer/alternate housing arrangements involve consolidations of juvenile detention operations among various counties. The Warren County Juvenile Detention Center closed on December 31, 2008, and began sending juveniles requiring secure detention to Morris County. The Passaic and Gloucester County juvenile detention centers closed on April 3, 2009 and June 3, 2009, respectively. Juveniles requiring secure detention in Passaic County are sent to Essex County. Juveniles requiring secure detention in Gloucester are transferred to the Camden, Middlesex, Cumberland and Burlington County detention facilities. The Sussex County Juvenile Detention Center closed on December 15, 2009, and began sending juveniles requiring secure detention to Morris County. The Monmouth County Juvenile Detention Center closed on July 1, 2010, and began sending juveniles requiring secure detention to Middlesex County.



The first set of statistical tables, beginning with Table I, documents the actual number of admissions and related child care days for each detention facility. In addition, a set of adjusted tables identified by an "A", beginning with Table I-A (Adjusted), is being provided, where applicable, to depict the figures for the counties noted above, had there been no transfer/alternate housing arrangements.

For operational purposes in 2010, Bergen County juveniles were first admitted to the Bergen County detention center and counted as admissions, then transferred to the Morris and Union County detention centers where they were again counted as admissions. The adjusted tables differ from the regular tables in that admissions and related child care day figures for Morris and Union Counties are lower on the adjusted tables, due to the subtraction of admissions and related child care days of juveniles transferred to Morris and Union Counties from Bergen County. Consequently, the total child care days for those transferred are added to Bergen County's total on the adjusted tables, while Bergen's admissions remain unchanged.

For Warren and Sussex Counties, the adjusted tables differ from the regular tables in that admissions and related child care day figures for Morris County are additionally lower on the adjusted tables, due to the subtraction of admissions and related child care days of juveniles transferred to Morris County from Warren and Sussex Counties. Total admissions and child care days for those transferred are added to Warren and Sussex County's total on the adjusted tables.

The figures for Camden, Burlington, Cumberland, Middlesex and Essex Counties differ on the adjusted tables from the regular tables due to the subtraction of admissions and child care days transferred to those facilities by Gloucester, Monmouth and Passaic Counties. Total admissions and child care days for juveniles transferred to these counties are added to Gloucester, Monmouth and Passaic Counties' totals on the adjusted tables. With regard to Union County, the adjusted tables differ from the regular tables in that admissions and related child care figures for the federally detained juveniles are subtracted from Union County's total.

The reports present two-year comparisons as well as five-year statewide comparisons where appropriate. Please note that the statistics in Tables I through VII and Tables I-A (Adjusted) through VII-A (Adjusted) do not include juveniles admitted to juvenile detention commitment programs. All statistics in Table X and Table X-A (Adjusted) and thereafter, include all juveniles admitted to detention, predispositional as well as commitment program admissions, for the purpose of presenting a true reflection of the number of juveniles in detention facilities. There is no Adjusted Table XII because it is identical to the unadjusted Table XII.

Tables XIV and XV present juvenile detention rates for the period from 2006 to 2010. There are several methods of determining juvenile detention rates and for this report we have selected two methods. The first is based on delinquency complaints filed, in each year. The second is based on population figures for statewide estimates of juveniles age 10-17.

Detention rates based on delinquency complaints filed are calculated by taking the number of juveniles admitted to detention statewide, dividing by the number of delinquency complaints filed in court statewide, and multiplying by 100 for each calendar year 2006-2010. Tables XIV and XIV-A (Adjusted) provide the figures for detention rates per 100 delinquency complaints filed.

Detention rates based on population are calculated by taking the number of juveniles admitted to detention statewide, dividing by the estimated number of juveniles age 10-17, and multiplying by 1,000. Tables XV and XV-A (Adjusted) provide the figures for statewide population estimates for juveniles age 10-17, admissions to detention statewide, and the detention rates per on thousand juveniles age 10-17.

Please note that Cape May, Hunterdon, Salem and Somerset counties also do not operate juvenile detention centers. These counties send juveniles needing secure custody to neighboring county juvenile detention facilities. Cape May, Hunterdon and Salem counties are not listed in the statistical tables as a result. In the case of Somerset County, all juveniles needing secure detention in Somerset County are transferred to the Middlesex County Juvenile Detention Center. For statistical purposes, Somerset County's admissions and child care days are listed separately from the Middlesex County figures in adjusted Tables I-A through IX-A.

The Gloucester and Passaic County juvenile detention centers closed on April 3, 2009 and June 3, 2009, respectively. All juveniles requiring secure detention in Gloucester County are sent to the Burlington, Camden, Cumberland and Middlesex County detention facilities. All juveniles requiring secure detention in Passaic County are sent to the Essex County juvenile detention center.

The Sussex County Juvenile Detention Center closed on December 15, 2009 and began sending juveniles requiring secure detention to the Morris County detention facility.

***The Monmouth County juvenile detention center closed on July 1, 2010. All juveniles requiring secure detention in Monmouth County after the closing were transferred to the Middlesex County juvenile detention center. Figures in Table I and subsequent tables for Monmouth County reflect the number of juveniles held in the Monmouth facility up to the date of closure.

An additional adjustment to Table 1 is due to the placing of a "soft cap" in January 2006 on the Bergen County Juvenile Detention Center. Prior to reaching the "soft cap," Bergen County has transferred juveniles requiring secure detention to Morris and Union Counties. For operational purposes in 2010, Bergen juveniles were first admitted to the Bergen County detention facility and counted as admissions, then transferred to the Morris or Union County detention facilities where they were again counted as admissions. Revisions to Bergen County's figures are due to the addition of child care days from Union and Morris Counties. Bergen County's admissions remain unchanged. Subsequently, admission and child care figures for Union and Morris Counties are lower here as compared with the Table 1 figures, due in part to the subtraction of admissions and child care days of juveniles transferred from Bergen County. Also, Union County entered into an agreement with the U.S. Department of Health and Human Services in July 2009 to house a maximum of 15 federally detained juveniles in the County's juvenile detention center. Revisions to Union county's figures are due in part to the subtraction of the federally detained juveniles. Table 1 and subsequent non-adjusted tables document the number of admissions and child care days for youth actually detained in each facility. All adjusted tables depict the figures for Union, Bergen and Morris Counties had there been no transfer/alternate housing arrangements.
