

MINUTES OF MEETING

The meeting was called to order by Chairman Lawrence Henderson.

At the commencement of the meeting, the Chairman, pursuant to section 5 of the Open Public Meetings Act, entered this announcement into the minutes of the meeting:

(a) prominently posted in a public place at the offices of the Public Employment Relations Commission;

The General Counsel distributed his monthly and supplemental reports.

The first case for consideration was City of Paterson and PBA Local 1 & PBA Local 1 SOA, Docket Nos. CO-2005-138 & CO-2005-139. Commissioner Watkins moved the draft decision and Commissioner Fuller seconded the motion. The motion was unanimously approved (Chairman Henderson, Commissioners Buchanan, DiNardo, Fuller and Watkins).

The next case for consideration was New Jersey Transit and Fraternal Order of Police, Lodge #37 (Superiors), Docket No. SN-2007-018. Commissioner Watkins moved the draft decision and Commissioner Buchanan seconded the motion. The motion was unanimously approved (Chairman Henderson, Commissioners Buchanan, DiNardo, Fuller and Watkins).

The next case for consideration was Township of Union and Superior Officers Association of P.B.A. Local 69, Docket No. SN-2007-031. Commissioner Fuller moved the draft decision and Commissioner DiNardo seconded the motion. Commissioner Watkins

The next case for consideration was Somerset County Sheriff's Office and Somerset County Correction Officers' P.B.A. Local No. 177, Docket No. SN-2007-038. Commissioner Watkins moved the draft decision and Commissioner DiNardo seconded the motion. The motion was unanimously approved (Chairman Henderson, Commissioners Buchanan, DiNardo, Fuller and Watkins).

The next case for consideration was City of Jersey City and Jersey City PSOA, Docket No. SN-2007-044. Commissioner Fuller moved the draft decision and Commissioner Watkins seconded the motion. Commissioner DiNardo recused himself because he has relatives on the Jersey City police force. The motion was unanimously approved (Chairman Henderson, Commissioners Buchanan, Fuller and Watkins).

The next case for consideration was Borough of Pompton Lakes and Pompton Lakes Police Benevolent Association, Local No. 161, Docket No. SN-2007-050. Commissioner Watkins moved the draft decision and Commissioner DiNardo seconded the motion. The motion was unanimously approved (Chairman Henderson, Commissioners Buchanan, DiNardo, Fuller and Watkins).

The next case for consideration was Bergen County Special Services Board of Education and Bergen County Special Services Education Association, Docket No. SN-2007-052. Commissioner DiNardo moved the draft decision and Commissioner Fuller seconded the motion. The motion was unanimously approved (Chairman Henderson, Commissioners Buchanan, DiNardo, Fuller and Watkins).

The next case for consideration was Borough of Spotswood and P.B.A. Local 225, Docket No. SN-2007-053. Commissioner Fuller moved the draft decision and Commissioner DiNardo seconded the motion. Commissioner Watkins recused himself because the employer's attorney works with him in connection with his employment as Administrator of South Brunswick Township. The motion was unanimously approved (Chairman Henderson, Commissioners Buchanan, DiNardo and Fuller).

The last case for consideration was City of Trenton and P.B.A. Local 11, Docket No. SN-2007-045. Commissioner Watkins moved the draft decision and Commissioner Fuller seconded the motion. The motion was unanimously approved (Chairman Henderson, Commissioners Buchanan, DiNardo, Fuller and Watkins).
