**INSTRUCTIONS FOR FILING
A PETITION FOR AMENDMENT OF CERTIFICATION**

1. This petition is appropriate only to record changes in the NAME or AFFILIATION of the certified representative and may not be used to alter the unit structure or the basic identity of the certified representative. If you have any questions, call the Commission's designated officer of the day at (609) 292-6780.
2. Type or print all requested information.
3. If you need more space to complete any item, attach additional sheets and number them accordingly.
4. Fill in all sections of this petition. If you believe that a section of this petition does not apply in your situation, mark the section "N/A" or "none". Failure to provide all information required by *N.J.A.C. 19:11-1.6* may delay processing of the petition.
5. Submit an affidavit attesting that the membership of the certified employee representative voted in favor of the change in name and/or affiliation. Such affidavit shall specify that:
 - a) The membership was given advance and adequate notice of the election as evidenced by an attached copy of a notice of election and a statement of the date of the notice and the manner in which it was provided to members;
 - b) The election was conducted by secret ballot, as evidenced by an attached copy of the ballot, and was held within six months of the filing of the petition;
 - c) The majority voted in favor of the change in name and affiliation, as evidenced by a document setting forth the results;
 - d) The composition and approximate size of the negotiations unit represented by the certified representative has continued unchanged since the affiliation vote was taken.
 - e) The officers of the certified representative have continued as officers since the affiliation although the officers may now hold different titles.
 - f) The certified representative does not object to the affiliation and name change.
