### **ACQUISITION OVERVIEW**


The Office of Dr. James Still is the first African-American historic site to be acquired and interpreted by the NJ Department of Environmental Protection. As the inaugural African-American state-owned historic site and to address an incredibly important legacy, the NJ Department of Environmental Protection strives to create a "First Class Historic Site." This briefing provides background information on Dr. Still, his office and his family. Further, this briefing outlines what we envision as the development potential of this incredible resource.

### DR. JAMES STILL

- Son of former slaves
- > Self-taught medical practitioner (not trained or licensed)
- > Distinguished himself as a seller of botanical remedies of his own devising
- > Recognized for the effectiveness of his treatments
- Surmounted many challenges to become one of NJ's most respected doctors
- > Served a large white and black clientele
- > One of 19th Century Burlington County's largest property owners
- Published Autobiography, Early Recollections and Life of Dr. James Still in 1877
- Upon his death, his possessions appraised at a value of \$19,921

Historic Image of the Office of Dr. James Still (left) and homestead. As Dr. Still was one of Burlington County's largest landowners in his era, these are just two of the many properties he owned. The illustrious three-story home was demolished in 1932. The office remains.

### OFFICE OF DR. JAMES STILL

- Located on Church Road in Medford Township, Burlington County
- Listed on State and National Registers of Historic Places, 1995
- Constructed in mid to late 1850s
- > Served as location of medical practice from late 1850s to his death
- > Property Acquisition
  - 8.8 acre parcel which is location of former medical office and homestead
  - Was at risk of being demolished to make way for zoned commercial development
  - Acquired by the NJ Department of Environmental Protection in February 2006 through the Green Acres Program for \$875,000

#### FAMILY OF DR. JAMES STILL

- > Parents: Levin and Charity Still—both formerly slaves in Maryland
- Siblings: had 17 siblings; brother, William, was an Underground Railroad pioneer conductor and author of The Underground Railroad, which accounts the lives of runaways that traversed Philadelphia; brother, Peter's story of enslavement, freedom and quest to free his wife and children is narrated in Kate E. R. Pickard's The Kidnapped and the Ransomed
- Children: Dr. Still and his wife, Henrietta Thomas Still, had seven children; son, <u>James</u>, <u>Jr.</u> was the third African American to graduate from Harvard Medical School, which he earned in 1871 with honors; son, <u>Joseph</u> sustained his father's legacy, serving as an herbalist in Medford and later Mount Holly
- Descendants: there are presently over 2,000 Still Family members in the Delaware Valley, many of whom live in Lawnside, Mount Laurel and Vineland


- Preeminent resource

- > Educational Materials: traveling trunk, lesson plans




Approach to Office of Dr. Still. The property is located on Church Road, Medford Township, Burlington County
