#### Content Note

This series includes certificate books for the transfer of capitol, consolidated, and preferred stock. The "common" capitol stock transfer certificate books date from 1844, when the stock was authorized, to 1862, after which time capitol stock was no longer transferred. The consolidated stock transfer certificate books date from 1857, when the common stock was consolidated, to 1954. The Preferred Capitol Stock Transfer Books dated from 1850 to 1949. There are duplicates for the consolidated and preferred stock transfer certificates for 1900-1911.
