OV-6	Quintipartite indenture, Sir George Carteret, William Penn, Gawen Lawry, Nicholas Lucas and Edward Billinge, establishing partition of New Jersey, 1 July 1676.
OV-7	Indenture of Thomas Hooten to John Pope and Anthony Elton for one ninetieth of the ninety one-hundredths of West New Jersey, 2 June 1677.
OV-8	Confirmatory grant, James Duke of York to Edward Byllynge, William Penn, Gawen Lawry, Nicholas Lucas, John Eldridge and Edmond Warner for West New Jersey, 6 August 1680.
OV-9	Tripartite indenture, Province of New York, Eastern Division of the Province of New Jersey and Western Division of the Province of New Jersey, fixing the northern partition point of New York and New Jersey, 25 July 1719 [fragmented].

- OV-10 Tripartite indenture, Susanna Dinsdale, Calvert Bowyer and Thomas Bowyer, three of the devisees named in trust in the will of John Dinsdale; Thomas Dinsdale and Joseph Dinsdale, sons of John Dinsdale and devisees named in trust in the will of Joseph Dinsdale; to Richard Smith and Ebenezer Large for one third of one ninety one-hundredth of West New Jersey, 29 March 1746.
- OV-11 Indenture, Elizabeth Byerly to Israel Pemberton for Thomas Byerly's share of West New Jersey, 17 & 18 May 1763 [includes certification of William Bedford, Lord Mayor of London, 2 June 1763].
