In addition, you will gain the knowledge and understanding of government and corporate culture, networking and public policy engagement.

Application Guidelines

- Faxed applications are **not** accepted
- Deadline to apply is Friday, December 18, 2020
- It is the applicant's responsibility to notify the New Jersey Center for Hispanic Policy, Research and Development (CHPRD) of any address or phone number changes during the interview, selection and notification process.
- Applicants taking academic courses during normal business days from June 7, 2021 through August 6, 2021, will not be considered.
- Applicants planning vacation or leave time between June 7, 2021 through August 6, 2021, **will not** be considered.
- Candidates seeking credit for his/her participation must arrange with the College/University's cooperative education or internship department.
- All sections must be completely filled out.

Program Requirements

- U.S. Citizen or Legal Permanent Resident
- Resident of New Jersey
- Of Hispanic descent
- Enrolled in a 2 or 4 year college/university program

All applicants are required to submit the following:

- Copy of a clear Photo I.D.
- Personal Statement
- One Letter of Recommendation
- Official transcript
- Essay Question
- Resume listing employment, community service experience, honors, computer skills and extracurricular activities.
- Respond to the essay question. It must be no more than 700 words, typed, font 12, double spaced and make use of MLA guidelines
- **Personal statement** use separate sheet. It must be no more than 300 words, typed, font 12, double spaced and make use of MLA guidelines.

- If invited, an interview will be scheduled with the Center for Hispanic Policy, Research and Development. You will be notified of the outcome of the selection process and may be required to undergo a background check.
- On Wednesdays inters are required to attend the Leadership Seminar of the Fellows Program. **Attendance is mandatory.**
- Students must work 28 hours weekly at their intern placement site and attend weekly training sessions that are 7 hours in duration each. <u>Vacation time is not allowed during the eight weeks</u>.
- Students seeking credit for their internship must abide by their College/University's work hours requirement (please make sure you inform the Center).
- All interns selected **must** complete all institute assignments and projects, which include completion of a policy paper.
