

Opportunity to Participate in the 2021-2022 New Jersey State Trade Expansion Program (NJ STEP)

The New Jersey Business Action Center, through its Office of Export Promotion, offers export assistance to eligible New Jersey businesses. The assistance is funded in part through a grant from the U.S. Small Business Administration and is available on a first come, first-served competitively awarded basis for export events from **September 30, 2021** through **September 29, 2022.**

To apply for NJ STEP, New Jersey companies MUST complete and submit the following: Information Survey; Projected Return on Investment; Invoices and proofs of payment for the export activities of which NJ STEP support is being requested; Business Assistance or Incentive Clearance Certificate for the New Jersey Secretary of State; Register for a vendor number through NJSTART; U.S. SBA - Eligible Small Business Concern Form; and U.S. SBA - SF 1624 Form.
