Deadline to apply for a Mail-In Ballot by Mail for September Special School Board Elections

(not less than 7 days prior to election)

Mailing of Sample Ballots for September Special School Board Elections

(on or before 12 noon on Wednesday preceding election)

(Consistent with requirements prior to the implementation of early voting which does not apply to school elections)

September 19

Last Day for Testing of Electronic Scanning Equipment for Tabulation of Paper Ballots for September Special School Board Elections

(A county board of elections may begin opening the inner envelopes for each mail-in ballot and canvassing each mail-in ballot from the inner envelope no earlier than five days prior to the day of the election-September 24)

(notice to be given 48 hours prior to the start of testing)

Deadline for Application to Receive September Special School Board Election Mail-In Ballots by Electronic Means for Qualified Overseas Civilian and Military Voters

(4th day before election)

Impoundment Period for Voting Machines Used in the September Special School Board Elections that are exempted by paragraph (2) of subsection b. of R.S. 19:48-1

(13 days following the closure and locking of the voting machines to comply with P.L. 2023, c. 124)

September 26

Deadline for Receipt by County Boards of Elections of Mail-In Ballots by delivery of the United States Postal Service that DO NOT Bear a Postmark of Delivery

(no later than 48 hours (2 days) after the time of the closing of the polls for the election)

September 30

Deadline for Receipt of Timely Mailed Postmarked Mail-In Ballots to County Boards of Election

(no later than 144 hours (6 days) after the time of the closing of the polls for the election)

Deadline for Receipt of Cure Form to County Boards of Election

(no later than 48 hours (2 days) prior to the final certification of the results of the election)

(within 13 days after election)
