N.J.S.A. 19:61-9: AUDITS OF ELECTION RESULTS

November 8, 2022 General Election and Audit Date: November 29, 2022

The Burlington County Board of Elections performed a post-election audit consistent with the provisions of N.J.S.A. 19:61-9 and the guidelines promulgated by the New Jersey Secretary of State's Office on Tuesday, November 29, 2022. The audit was open to the public and our Board was present.

The Burlington County Board of Elections conducted a hand-to-eye count for the November 8, 2022 General Election for the offices of the U.S. House of Representatives, General Assembly District 12, County Sheriff, Municipal Mayor or Council/Committee in all batches selected. In accordance with the law, Public Questions, School Elections, and Fire District Elections were not audited.

Pursuant to the statute, "the audit shall be conducted in at least 2% of the election districts in which each audited election appears on the ballot." The guidelines provided for this audit require 2% of the audit units in each of the congressional districts to be randomly selected. Audit units included: early voting ballots, vote-by-mail ballots, and provisional ballots. In total, 537 audit units were created.

There are two Congressional Districts in Burlington County: The First and Third. There were 18 audit units for the 1st Congressional District and 2 batches were audited. There are 519 audit units for the 3rd Congressional District and 11 batches were audited.
