

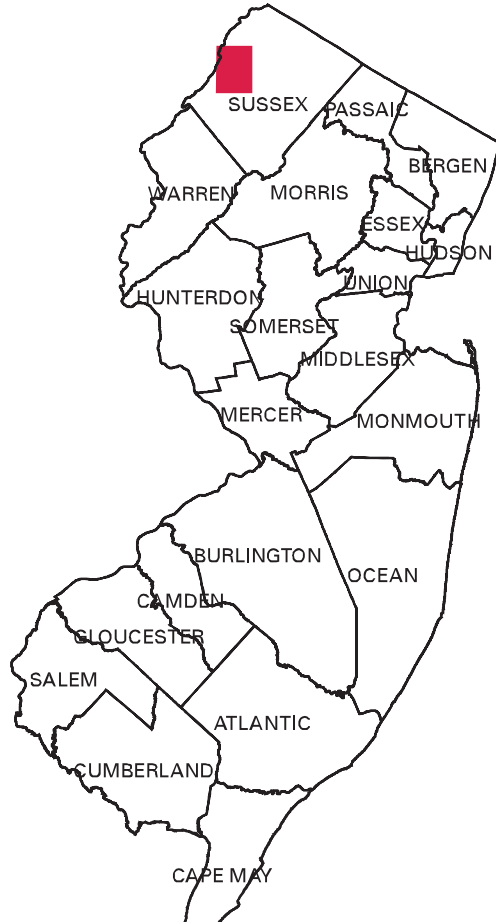
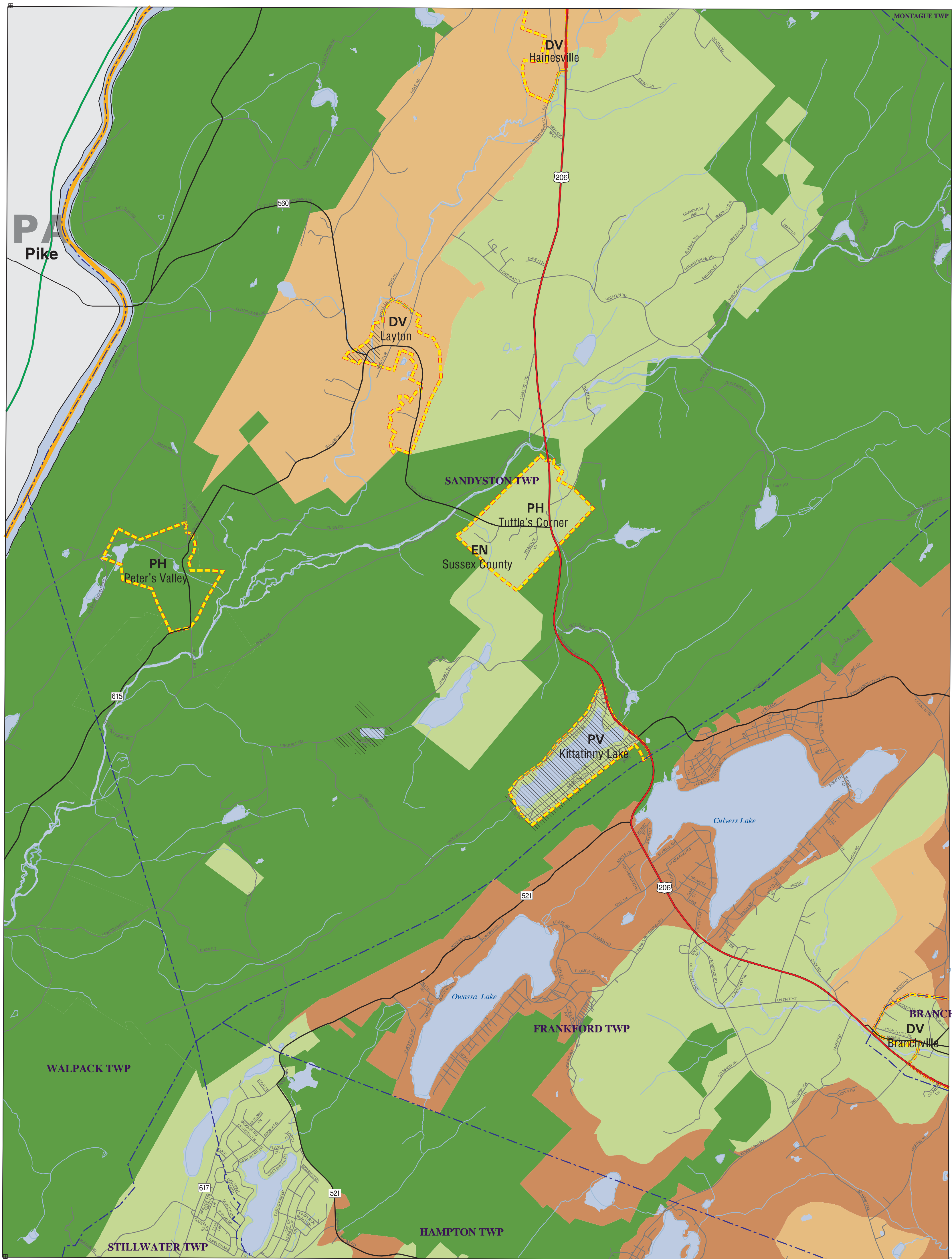
# POLICY MAP

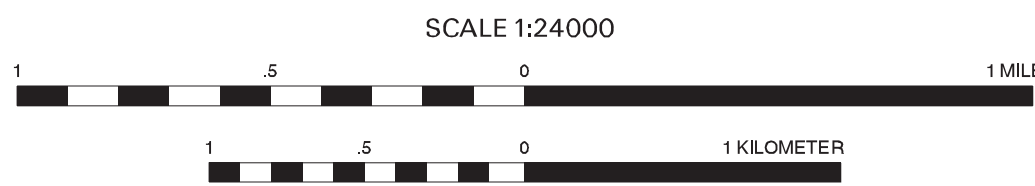
