Route 73, Granite Avenue to Route 41 Bicycle and Pedestrian Improvements

Townships of Maple Shade and Mount Laurel, Burlington County, NJ

Background

This project includes a 2-mile segment of Route 73 where several fatal pedestrian crashes have occurred in recent years. There is a lack of sidewalks and bicycle facilities along this section of Route 73. High levels of pedestrian and bicycle activity occur throughout the corridor, and pedestrians have been observed crossing Route 73 at mid-block locations where median barrier and a curbed grass median are present. The purpose of the project is

to improve the safety, accessibility, and mobility of bicyclists and pedestrians along Route 73 within the project limits.

The Project

The Preliminary Preferred Alternative for the project includes the following:

- Installation of an 8-foot to 10-foot wide Shared Use Path to accommodate pedestrians and bicyclists. The Shared Use Path is proposed along Route 73 northbound and southbound between the Waverly Avenue and Fox Meadow Drive signalized intersections.
- Installation of median fencing between Waverly Avenue and Fox Meadow Drive. The fencing will be installed on the median barrier and within the grass median.
- The Route 73 and Waverly Avenue signalized intersection will be upgraded to provide highvisibility crosswalks, pedestrian countdown signal heads and pushbuttons, ADA-compliant curb ramps, and a Leading Pedestrian Interval to provide additional crossing time for pedestrians.

Estimated Schedule

Start Preliminary Engineering: Summer 2021

Start Final Design: Fall 2022 Start Construction: Fall 2024

Complete Construction: Summer 2025
