What is the overall deductible?	\$0 – Deductible does not apply	First day, first dollar coverage. You do not have to meet a <u>deductible</u> amount before this plan begins to pay for covered services you use. See the chart starting on page 2 for how much you pay for covered services.
Are there services covered before you meet your deductible?	Yes. All eligible services.	This <u>plan</u> covers items and services that do not require a <u>deductible</u> to be met.
Are there other deductibles for specific services?	No	You don't have to meet <u>deductibles</u> for specific services, but see the chart starting on page 2 for other costs for services this plan covers.
What is the <u>out-of-pocket</u> <u>limit</u> for this <u>plan</u> ?	Yes. For in-network and out-of-network providers \$400 out of pocket maximum. This is a combined annual maximum for in-network and out-of-network services.	The <u>out-of-pocket limit</u> is the most you could pay during a coverage period (usually one year) for your share of the cost of covered services. This limit helps you plan for health care expenses.
What is not included in the <u>out-of-pocket limit?</u>	Premiums, balance-billed charge for a Medicare provider who does not accept Medicare Assignment, and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the <u>out-of-pocket limit</u> .
Will you pay less if you use a <u>network provider</u> ?	Yes, but not required as long as the provider accepts Medicare. However, members need to use a <u>licensed provider</u> with Medicare.
Do you need a <u>referral</u> to see a <u>specialist</u> ?	No.	You can see the <u>specialist</u> you choose without a <u>r</u> eferral.

Your Rights to Continue Coverage:
