PENALTIES FOR FAILURE TO FILE REPORT, OR FILING OF FALSE OR FRAUDULENT REPORT.

Any person who shall fail to file any report required to be filed pursuant to the provisions of this title, or shall file or cause to be filed, with the Director, any false or fraudulent report or statement, or shall aid or abet another in the filing with the Director, any false or fraudulent report or statement, with the intent to defraud the State or evade the payment of any tax, penalty or interest or any part thereof, which shall be due pursuant to the provisions of this title, shall be punished in accordance with the State Tax Uniform Procedure Law, R.S. 54:48-1 et seq.

Title 54 of the Revised Statutes, as amended and supplemented, provides that any licensee filing this report late shall be liable for a late filing penalty of \$100.00 for each month or fraction thereof that this report is delinquent.

This report shall cover two calendar months' business from the first to the last of the two month period inclusive, and shall be signed by the licensee, or the proper officer if the licensee is a corporation or by the duly authorized agent of the licensee. The report with the schedules shall be filed with the **Division of Taxation, Revenue Processing Center, Beverage Tax, PO Box 241, Trenton, NJ 08646-0241**, within FIFTEEN DAYS after the expiration of the period reported upon. Beverage Tax Reports shall be filed covering each bimonthly period or part of a period that a license is in force even though during the period no business is transacted under the license.

Under Subtitle 8 of Title 54 of the Revised Statutes, as amended and supplemented, transportation licensees are accorded a tax exemption on alcoholic beverages brought from a point outside the State to a point in New Jersey, only when such beverages are delivered to or for the account of a Manufacturer, Wholesaler, State Beverage Distributor, or Plenary Retail Transit Licensee.
