## FEMA Offers Mortgage and Rental Assistance

New Jersey residents who lost their jobs or the income of a loved one as a direct result of the September 11 terrorist attacks and who are now facing foreclosure or eviction, may be eligible for mortgage or rental assistance from the Federal Emergency Management Agency (FEMA).

To qualify for mortgage or rental assistance, you must have been living in the residence when the terrorist attacks

occurred and have suffered disaster-related financial hardships, such as a loss of employment or income. In addition, you must have received written notice of foreclosure or eviction proceedings and be unable to make mortgage or rent payments.

To register for FEMA's mortgage or rental assistance call 1-800-462-9029. Hearing-impaired callers may use FEMA's TTY number at 1-800-462-7585. Both lines are staffed 8 a.m. to 8 p.m. Monday through Saturday.

## Financial Planning Help Available

The Financial Planning Association is providing free financial advice to families of WTC attack victims. Trained professionals are staffing the association's National Support Hotline to provide families important information on:

- medical, disability and/or life insurance benefits, settlements and claims
- banking issues, payment of bills and budget and cash flow management
- organization of family finances
- working with other professionals, such as accountants, attorneys and insurance professionals
- how to work with relief agencies to access all available financial benefits to which you and your family may be eligible.
