New Jersey Memorial

New Jersey will construct a September 11th Memorial as a lasting symbol of our resolve to honor those who died by rising above the evil that claimed their lives. The Memorial will be sited at Liberty State Park in Jersey City, New Jersey, directly across the Hudson River from "Ground Zero" in Lower Manhattan. The massive attack on September 11th 2001, that claimed the lives of 700 New Jerseyans, was intended to break our spirit. It has not done that. It has made us more determined and more resolved.

As many of you know, the search for a fitting New Jersey September 11th Memorial to honor the courageous men and women from our state lost in the Terrorist Attacks was first announced in July 2003. Unfortunately, that effort yielded only 19 proposals by the deadline and all were found unsuitable by the Family Memorial Committee. Many were not compatible with the 1.6 acre site in the northeast end of Liberty State Park. The State is looking for a design that may be seen from lower Manhattan, which incorporates the history of Liberty State Park, including its grove of trees planted last Arbor Day as a living memorial to September 11th victims and its significance to the rescue efforts that took place that day.

As a result, I have renewed New Jersey's nationwide search for memorial proposals. The new deadline is April 30, 2004. However, all entrants must register by March 1, 2004. The Memorial process will involve a stage in which a Professional Advisory Committee, made up of several distinguished design professionals and a Liberty State Park representative, will review the initial entries for compliance with the regulations and begin the winnowing process. The Professional Advisory Committee will present its selection of final designs to members of the Family Memorial Committee which will select the winning design.

As Governor, I encourage designers, architects, artists and any other interested individuals to submit a concept design for the memorial.

The State has set up a website at: www.nj.gov/nj911memorial/ nj911_rfp.pdf which sets forth its request for proposals. Proposers may register on-line, or by mailing the registration form in the Request for Proposal.

Funding for the New Jersey Memorial will be provided in part through private donations.

Federal Victim Compensation Fund

By the time the deadline for applying to the VCF arrived on December 22, 2003, close to ninety-eight per cent (2,924 families) of those eligible to apply had done so according to Fund administrator Kenneth R. Feinberg.

Congress did not set a limit on the amount that could be distributed to these families who have surrendered their right to sue the airlines by applying to the VCF. Projections are that the total could reach \$6 billion. In death cases, awards have ranged from \$250,000 to \$6.9 million with the average payout at \$1.8 million. Injury awards ranged from \$500 to \$7.9 million in the case of a person who was severely burned.

Update

Legislative Update

Governor McGreevey has signed **S-1926** into law. The new law authorizes the establishment of a trust for young beneficiaries which may defer distribution past age 18 in situations where no will exists. Awards from the Victim Compensation Fund may be included in a trust created under this new law.

A number of victims of the September 11th Terrorist Attacks who had young families died without wills, and their widows supported this legislation. Prior to this, when a minor was the beneficiary of funds from an estate where the decedent died without a will, the funds could be held in trust for the minor's benefit until he reached the age of 18. At that point, his guardian was required to distribute all of the funds to him.

For more information on how this new law may assist you, please consult your lawyer or accountant.

The Governor has also signed **S-1924** into law at the request of WTC Families for a Proper Burial. This group is working to have the ashen remains of their loved ones retrieved, environmentally containerized, and buried with dignity and respect as part of the Memorial to be erected at the WTC site in Manhattan. The new law requires the Port Authority of New York and New Jersey to comply with the group's request.

The remains are currently located at Fresh Kills landfill in Staten Island, New York. Approvals of the New York State Legislature and the city of New York will be required for this action to occur.

S-1234 which establishes a September 11th Memorial license plate and dedicates the fees to support the New Jersey Memorial and victims injured in the attack has also become law as the result of Governor McGreevey's approval.

Health Insurance

During the past two years, several people have been working to create a special health care plan to cover the families of September 11th 2001 Terrorist Attacks' victims. They have obtained consent from a major insurance carrier to insure the group. They have also gained tentative approval for formation of a recognized group from the relevant regulatory agencies.

They have sent the 1500 potential families that could participate in the group plan two questionnaires. Approximately 650 have been returned. Ultimately, it is not likely that the insurer and the state regulators will allow the program to go forward if enough people do not respond.

The organizers expect to learn shortly what the insurance companies will require as the threshold number of participants to ensure a viable insurance plan. If the organizers can meet that number, they will next seek funding from sponsors because the insurance plan must be partially funded to satisfy some regulatory requirements. Funding sources should also reduce the insurance premium cost. Also, the more plan participants, the lower the premiums.

The proposed plan would provide comprehensive coverage, including medical, hospital, prescription drug and vision benefits. Plan members would see participating health care providers for a reasonable co-payment and would be able to receive services from specialists without the approval of any "gatekeepers."

You could assist the organizers now by filling out their questionnaire. Filling out this form does not sign you up for a new health insurance plan. It simply allows the working group to collect demographic information and plan more effectively for the needs of the population.

For example, you may have been given health insurance coverage for 5 years by your spouse's former employer and think that you need not fill out the questionnaire. However, the organizers suggest that at this point, you have only 2.5 years of coverage left. You will need insurance at the end of that period and, if they can achieve their goal, this plan would be available to you at that time.

Another example of someone who could use the plan in the future, if not immediately, would be a widow who is working now and has her own coverage. Should she decide to only work part time or not at all, she could also be covered by this plan when she is no longer covered at her job.

Art for Heart

In 2003, children of victims of the September 11th 2001 Terrorist Attacks were invited to participate in the therapeutic art program called Art For Heart. World Trade Center Memorial

On January 6, 2004 the World Trade Center Site Memorial Competition Jury selected "Reflecting Absence" by Michael Arad and landscape architect Peter Walker as the winning design. The selection was made from a field of 5,201 entries and was among eight finalists which had been announced last November and displayed at the World Financial Center Winter Garden.

The winning design underwent several revisions which were unveiled on January 14, 2004. The revised design added landscaping and includes the names of each victim displayed at random with members of the police and fire departments bearing their respective agency insignia. It also includes a private meditative space for the families of victims and a sanctuary at the bottom of one of the footprints housing unidentified remains. In addition, an underground museum and interpretive center have been added. The winning design is now on display from 10:00 a.m. to 10:00 p.m. daily at the Winter Garden.

World Trade Center Relief Fund

New York State established the World Trade Center Relief Fund immediately after the September 11th 2001 Terrorists Attacks to provide surviving spouses, partners, children and parents with assistance and support. Past distributions of this fund focused on surviving relatives. New York is now seeking to disburse similar benefits to those injured in the attacks. Injured clients should apply directly to the state for this benefit. 9/11 Independent Commission

On January 26 and 27, 2004, the Independent Commission held its seventh hearing. At the close of the session, the Commissioners requested that Congress amend the statute which created the Commission to extend the deadline for completing its report by at least 60 days. This request would change the due date to July 26, 2004. The Commissioners added that they expected Congress to leave untouched the 60 days in the current statute for administrative work. In response, the Family Steering Committee issued a statement on January 29, 2004, requesting a January 2005 deadline. They also stated that they do not support the Commission's request for an extension of only two months.

In addition, it has been reported that bi-partisan legislation to extend the deadline for the Independent Commission report until after the presidential election will be introduced in Congress.

Development of Park at Fresh Kills

Pursuant to the Mayor Bloomberg's announcement that a master plan was being devised for a "world-class park" at Fresh Kills, a former landfill, Nikki Stern, Governor McGreevey's NJ 9/11 Families representative, arranged a meeting between several families, including three New Jersey residents who are founders of WTC Families for a Proper Burial, officials with the City Planning Commission and the site planner to discuss how the recovery and temporary burial areas should be handled. "Although the discussions are very much in the formative stages," Ms. Stern reports that "the meeting afforded an opportunity for frank discussion. It was a positive first step and we intend to continue meeting and pressing to get answers as to the future of the site and what currently remains there."

Update

National Institute of Standards and Technology

The National Institute of Standards and Technology ("NIST"), part of the United States Commerce Department, has scheduled a public meeting for Feb. 12, 2004 in New York City. NIST will present an update on the progress and preliminary findings of the Federal Building and Fire Safety Investigation of the World Trade Center Disaster in response to the September 11th 2001 Terrorist Attacks and will solicit comments from the public on:

(1) specific technical aspects of the individual projects as reported in its December 2003 progress update and presentations to the National Construction Safety Team Advisory Committee (available on the NIST WTC Investigation Web site: http://wtc. nist.gov);

(2) information that NIST might consider in the time remaining that is within the scope of the eight projects described in the investigation plan (the plan is available at the same Web site); and

(3) areas that NIST should consider, within the scope of its investigation, in order to make recommendations for specific improvements to building and fire practice, standards, and codes, and their timely adoption.

Individuals and representatives of organizations who would like to offer comments may request an opportunity to speak at the public meeting. The total number of speakers and organizations, and the time available for each, will be determined by the number of requests, but the time is likely to be 5 to 10 minutes each.

Speakers will be selected based on the following criteria:

(1) Relevance of a 150- to 200-word summary of the proposed comments on any or all of the above three topics,

(2) order in which requests are received,

(3) balancing interests and perspectives, and

(4) avoidance of duplication in comments and suggestions.

Speakers who wish to expand upon their oral statements, those who had wished to speak but could not be accommodated on the agenda, and those who are unable to attend in person are invited to submit written statements and supporting material to the WTC Technical Information Repository by Feb.19, 2004. All comments received will be forwarded to the appropriate investigator for consideration.

Scholarship Funds

The Board of Trustees of the New Jersey World Trade Center Scholarship Fund ("the Fund") has approved scholarship amounts for the 2004-2005 academic year. Eligible applicants will receive scholarships up to \$6500 (\$3250 per semester).

Applications are available at the State Higher Education Student Assistance Authority (HESAA) Web site *www.hesaa.org* The application deadline for the Fall 2004 semester is October 1, 2004. Families who are registered with the Fund will receive a mailing in the next few weeks that will include an application. September 11 Scholarship Alliance which is coordinating scholarship funds created to assist families of people killed or permanently disabled in the terrorist attacks on America on September 11, 2001, including airplane crews and passengers, World Trade Center and Pentagon workers and visitors, and relief workers - including firefighters, law enforcement and port authority officers, and emergency medical personnel.

A number of scholarship funds have been established and scholarships are available for victims' dependent children, spouses, or domestic partners. The scholarships may be used to attend an accredited two- or four-year college, university, or vocational-technical school in the United States as well as in other countries. While most funds are directed to undergraduate study, some funds will provide scholarships for graduate study. Each of the funds has its own policies and requirements.

Each family member who is eligible for scholarship funds completes two steps: registration and application. Families of victims are encouraged to register all dependents, including young children (newborn to high school) and spouses/domestic partners, as soon as possible. Application for scholarship funds occurs when a dependent is graduating high school, enrolling in a post secondary school, or continuing pursuit of a degree for another semester/quarter.
