Help Shape Future of Lower Manhattan; Register to Join 5,000 Residents from NYC and Region

Historic Javits Center Event on July 20th Will Create Inclusive Vision For Redevelopment and Permanent Memorial

You can register to join approximately 5,000 residents of New York City and the surrounding region who will meet at the Jacob Javits Center on Saturday, July 20, for "Listening to the City," a day-long event devoted to shaping plans for the redevelopment of Lower Manhattan and the creation of a permanent memorial for 9/11.

"Listening to the City" – the largest forum of its kind – is being organized by the Civic Alliance to Rebuild Downtown New York City, a coalition of more than 85 civic, labor, business, environmental groups and academic institutions across the region, committed to ensuring that community voices are heard. The Civic Alliance is working closely with the Lower Manhattan Development Corporation (LMDC), the Port Authority of New York and New Jersey, the City of New York and other public and private organizations involved in the planning process.

Designed as a 21st Century town hall meeting, "Listening to the City" will employ modern interactive technologies that combine small and large group discussions to ensure a rich dialogue. Participants will have an opportunity to view and comment on alternative proposals for the site, adjacent areas and related transportation and to voice their opinions on a permanent memorial.

Participants will be seated in 10-to-12 person round-table discussions, each led by a trained facilitator who is skilled in small-group dynamics. Networked, wireless laptop computers will serve as "electronic flipcharts" to record ideas generated during the small group discussions.

Each table's input will be instantly

transmitted to a "theme team" that identifies emerging themes and ideas from the small group discussions. Each participant will then use wireless polling keypads to rank and vote upon the shared responses, with the results being instantly recorded and displayed.

Also on July 22, the Lower Manhattan Development Corporation will open a display of the preliminary land use plans for the WTC site at Federal Hall National Memorial at Wall and Nassau Streets. As many as six plans and possibly models and simulated three-dimensional tours of the site on computer monitors will be displayed in the rotunda of the Hall through the first week of September. Visitors will be able to leave written comments about the plans which will be refined in the coming months based on public input and the Javits Center discussions.

The display will be open weekdays from 9 a.m. to 5 p.m. Weekend and evening hours may be added later.

New Jersey Victims of Crime Compensation Board

The New Jersey Victims of Crime Compensation Board ("NJVCCB") has received more than 470 applications from victims for compensation. According to NJVCCB Chairman, Jacob Toporek, almost \$5 million has been awarded to surviving families of New Jersey residents who were victimized on September 11, 2001.

The NJVCCB assisted many claimants at the Family Assistance Center at Liberty State Park in making application for compensation to the New York Crime

Victims Board. Although New York has primary jurisdiction for compensation claims arising out of the World Trade Center bombing, the NJVCCB allows additional claims on behalf of New Jersey victims to be filed to assist in compensating them for losses not covered under New York law.

While the New York Crime Victims Board pays a maximum of \$30,000 for loss of support or earnings, the NJVCCB compensation program is authorized to award an additional \$25,000, the maximum benefit permitted by New Jersey statute. Also, the NJVCCB can reimburse certain family transportation expenses and funeral catering costs which New York's program excludes.

WTC families will be hosting rescue workers and their spouses. Family Advocate Program Update

As of July 8, 2002, 426 families have registered with New Jersey's Family Advocate Program (FAP) and been assigned individual advocates, according to Carolann Kane-Cavaiola, Executive Director of New Jersey Family Advocate Management, Inc.

The FAP, created by Governor James E. McGreevey, provides individual advocates for families who lost loved ones and for individuals who were physically injured in the September 11th Attacks. It is designed to meet long term needs through individual attention by experienced, trained advocates who assist families in gaining hassle-free access to resources, services, benefits and other programs particularly in the areas of charitable and private

benefits, legal, financial and mental health services, scholarship programs, job training and skill enhancement programs.

According to Ms. Kane-Cavaiola, 27 advocates from various social service agencies throughout the State have been assigned. Advocates have already received six specialized training programs to assist them in accessing benefits available to families.

Ms. Kane-Cavaiola stressed that new registrations are still being accepted. Individuals eligible to sign up for the FAP may do so by calling 877-688-5268, Monday through Friday, 8 a.m.- 5 p.m.
